Hon. Kilonzo (Majority Party Leader): Thank you Mr. Speaker Sir. Mr. Speaker, this is a motion on additional County Assembly sittings.

THAT; Pursuant to the provisions of the County Assembly standing order 27 part 3 b and c this assembly hereby resolves to have additional sittings on Thursday 27th and Friday 28th June 2019 both morning and afternoon sittings. This is to allow members adequate time to prosecute both supplementary budget for the year 2018/2019 and the County Budget estimates for the year 2019/2020.

Mr. Speaker Sir, this is just a way and for the fact that we have received the two estimates today, Mr. Speaker it would have been very good that these members go through them so that they can do the necessary amendments and we can allow them to get them submitted before tomorrow when we will be prosecuting them.

Mr. Speaker I think out of the lots of work we did out of this, my expectation was that the Budget estimates of 2019/2020 would be prosecuted earlier. Earlier, I mean when we have no pressure for any deadlines. Having said it is just a tradition or practice to have these two days for the vital job. I would want to mention about the special sittings and Mr. Speaker you will have to hear me this time. The special sittings which are actually gazette. Immediately, they are gazzeted, this Assembly usually has a whole day sitting and they are never paid.

I have no problem with the Thursday sitting but Mr. Speaker with your office and the office of the Clerk you must ensure that this Friday the 28th, these members are paid. It is their time and they need to be paid. With those few remarks Mr. Speaker, I want to request the minority leader to second the Motion.

Mr. Speaker Sir, away from that I want to strongly second this motion on special sittings on tomorrow Thursday morning session and on Friday. Mr. Speaker Sir, the work ahead of us is really tedious. We have the supplementary budget to look into and we have main budget for the year 2019/2020 which we are supposed to debate and approve before the 30th of this month which is the deadline.

Mr. Speaker Sir, it has been a norm that we always do this in a hurry. We have to do this every other time. We had to gazette today, this Friday in a rush. That is exactly what happened in the last financial year. I would want to request your office and the Committee on budget to always make sure that we have this document in time so that we can ventilate on it and make our necessary amendments in good time before the motion can be moved.

Mr. Speaker, this budget is very critical and it is what will make this Assembly be noticed to be doing something in this next financial year. We really want to encourage members of this House to thoroughly check this document and come up with necessary amendments if any before tomorrow so that we can listen to their input and Hon. Members will make the necessary measures to either adopt or reject the amendments we are talking about.

With those few remarks I want to second this Motion and request your office and that of the Clerk to ensure Hon. Members are paid when they attend the Friday sittings. Thank you Mr. Speaker.
