Honourable Members,

In adherence to our Assembly approved Annual Calendar (Regular Session), 2025, this House is scheduled to proceed for the August recess effective today Wednesday, 6th August, 2025. In this regard, this House will be debating a procedural motion on adjournment to proceed for the August recess 2025, pursuant to provisions of Standing Order No. 25(3) and resume its sittings on Tuesday 9th September, 2025 at 9.00 am. This House will also be debating a motion to alter the approved County Assembly annual calendar for the Fourth Session, 2025, by rescheduling the date of resumption from the August recess - from Tuesday, 2nd September to Tuesday, 9th September, 2025. allow the County Assembly time to hold a joint consultative meeting with the County Executive.

Honourable Members,

As we break for the August recess, I take this opportunity to reflect on the journey we have made since the House resumed sittings from the April recess on Tuesday 7th May, 2025 by highlighting key activities planned during the recess period. Through our tripartite role of legislation, oversight and representation as stipulated in Article 185 of the Constitution of Kenya, 2010, this House has made significant strides. Allow me to point out specific accomplishments we have made as a House this far: -

A. Motions

C. Oversight

Honourable Members,

As you are aware, the operations of the Assembly's select and sectoral committees resumed on 29th May, 2025, following the lapse of the interim orders which had restrained or limited the House's activities in relation to the reconstitution of its committees. However, despite this progress, there has been minimal committees' activities, which has continued to affect the Assembly's ability to fully execute its critical oversight, legislative and representative functions. I urge committee chairpersons and with their roles now take up members to its urgency and commitment so that we can resume robust committee engagements both during and after the recess. Our people expect and deserve a fully functioning Assembly that delivers on its mandate without delay.

Committees play a key role in the legislative process by carrying out legislative oversight, scrutinizing county policies, facilitating public participation exercises, investigating and carrying out inquiries into any matter within their jurisdictions, and making recommendations to the full House on matters within their

purview to guide legislative decisions, thus enhancing the effectiveness, efficiency and responsiveness of county governance.

During the period under review, various Assembly committees took time to execute their respective mandates by engaging in various activities ranging from report writing and oversight. Notable activities which were undertaken during the period include; -

- Inspection exercise of development projects implemented by the County Executive across the forty wards for FY 2024/2025 carried out from 1st -5th July, 2025 by the whole County Assembly.
- ii. Liaison Committee together with House leadership retreated to Nairobi from 21st to 26th July, 2025 to deliberate on and develop the County Assembly Committees' programme to facilitate the smooth functioning of the Assembly.
- iii. Committee on Health and Sanitation and County Budget and Appropriations retreated to Mwingi from 30th July to 3rd August 2025 to undertake pre-publication scrutiny of Facility Improvement Fund Bill, 2024.
- iv. Committee on Culture, Youth, Sports, Gender and Social Services has retreated to Mutomo with effect from 4th to 9th August, 2025 to consider and undertake pre-publication scrutiny of the following legislative proposals:
 - a) The Kitui County Sports Management Bill, 2024
 - b) The Kitui County Youth Empowerment and Development Policy 2025.

- v. Committee on Lands, Infrastructure and Urban Development has also retreated to Mutomo from 4th to 8th August, 2025 to deliberate on the proposed construction of ward offices for Members of the County Assembly.
- vi. The Public Accounts and Investments Committee (PIAC) has also retreated from 4th to 8th August, 2025 for an oversight exercise in a bid to obtain first-hand information on matters that often lead to audit queries by the Office of the Auditor General.

D. Public Participation Forums

During the period under review, the Assembly held a successful public participation forum on the Kitui County Budget Estimates for FY 2025/2026 in all eight sub counties. This was necessary in ensuring peoples inclusivity in budget making process pursuant to Article 196(b) of the Constitution of Kenya, 2010.

Honourable Members,

In order to ensure that more people have an opportunity to share their views on the County budget estimates for FY 2025/2026, we continued to embrace technology by organizing virtual public participation exercises through the Google Meet platform. This approach has proven to be the most interactive and effective way to reach Kitui residents living outside the county and allow them to voice their concerns and I commit to continue engaging our people through such platforms going forward to reach even more people.
