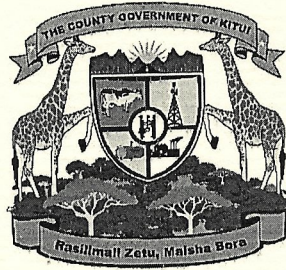

I therefore wish to communicate to this House the new leadership of the Minority Party as follows—

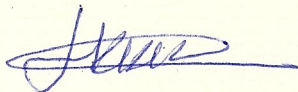
1. Minority Party Leader: Hon. Jeremiah Musee Mutua replaces Hon. Alex Mutambu Nganga
