

1.0 EXECUTIVE SUMMARY

Mr. Speaker,

The Committee on Selection is a County Assembly Select Committee established under Standing Order (S.O) 152. It is the Committee that is charged with the responsibility of formation of other County Assembly Committees save for the Committee on County Assembly Business and Committee on Appointments.

Mr. Speaker,

The Committee undertakes this noble role in outright consultation with the County Assembly Parties and in strict adherence to the provision of Section 14 of the County Government Act (CGA), 2012 which *inter alia* provides that: -

14(1)(a) & (b) “ *A county assembly—*

- (a) may make S.Os consistent with the Constitution and this Act regulating the procedure of the county assembly including, in particular, orders for the proper conduct of proceedings; and*
- (b) subject to S.Os made under paragraph (a), may establish committees in such manner and for such general or special purposes as it considers fit, and regulate the procedure of any committee so established.*

The Committee also undertakes its function in compliance with S.Os 152, 154 & 155 of Kitui County Assembly Standing Orders in regards to the establishment, formation criteria for nomination and approval of members to serve in County Assembly Committees.

Mr. Speaker,

Despite the above roles, the Committee also looks into delivery of mandate by County Assembly Committees which may be influenced by lack of quorum and sometimes failure to meet owing to over-sharing of membership especially when all County Assembly Committees are sitting. Additionally, the Selection Committee evaluates strength of Committees by much as practicable allowing members to extent their professional expertise in Committee service as contemplated by Section

9 (1)(e) of the CGA, 2012 which provides that a members of the County Assembly may extend professional knowledge, experience or specialized knowledge to any issue for discussion in the County Assembly. To enhance performance, the Committee on Selection also undertakes a continuous review of membership geared at addressing issues within her mandate that may be affecting Committees' performance.

Mr. Speaker,

In execution of her mandate as highlighted above, the Committee on Selection proceeded for a retreat at Mwingi 052 Leisure Resort from 11th to 15th December, 2025 to review, discuss and where necessary come up with a revised membership of some Committees for adoption by the Assembly.

In addition, political parties made some changes in an attempt to address gender in the current County Assembly Committees' composition in order to comply with Constitution 2010, the CGA, 2012 and Kitui County Assembly S.Os.

In undertaking the exercise, the County Assembly Parties did extensive consultations and where necessary bipartisan engagements were done in order to come up with a considered list of membership for consolidation by the Selection and adoption by the Assembly.

Mr. Speaker,

The re-composition and realignment contained in this report makes changes to the following Select and Sectoral Committee membership:

- i. Powers and Privileges,
- ii. Implementation,
- iii. Delegated Legislation,
- iv. Culture, Youth, Sports, Gender and Social Services,
- v. Tourism and Natural Resources,
- vi. Environment, Energy and Mineral Investments,

- ix. Trade, Industry, ICT and Cooperatives,
- X. Administration and Coordination of County Affairs,

Mr. Speaker,

The Committee on Selection urges the House to adopt this report on the revision of County Assembly Committees' membership that is geared towards improving the general performance and effectiveness of the Committees' service delivery.

2.0 PREFACE

Mr. Speaker,

On behalf of the Committee on Selection, I hereby wish to table the report by the Committee on re-constitution and review of membership to the County Assembly Select and Sectoral Committees that was conducted in furtherance of the Committee's mandate.

Standing Order 152(2) provides that;

The Committee on Selection shall nominate members to serve in Committees, save for the membership of the County Assembly Business Committee and Committee on Appointments.

The significant responsibility therefore to re-constitute and review membership of County Assembly Committees is thus vested with the Committee on Selection which is chaired by the Leader of the Majority Party and mandatory membership of;

- i. the Leader of the Minority Party, and
- ii. other Members drawn from independent and small parties.

3.0 THE CONSTITUTION AND MANDATE OF THE COMMITTEE

Mr. Speaker,

3.1 Committee constitution

The Committee on Selection is established pursuant to the provisions of Standing Order 152 which further states that the Committee shall be appointed within ten (10) days on the Assembly of a new County Assembly. This is thus an outright indication that the Committee is an important instrument that is key in facilitating and providing administrative services in the formation of other County Assembly Committees.

3.3 Committee Mandate

Mr. Speaker,

S.O 152(2) highlights the mandate of the Committee to nominate members to serve in County Assembly Committees as indicated above in this report. This function is exercised by the Committee in due regard to the County Governments Act, 2012 and the provisions of S.Os No.'s 153, 154, 155 and 157 among other laws.

4.0 BACKGROUND

Mr. Speaker,

The Committee on Selection has pursuant to her mandate been over the period undertaking a review of membership to County Assembly Select and Sectoral Committees. The exercise is undertaken in adherence to Sections 9(e) & 14(4) of the CGA, 2012 which inter alia provides: -

- i. Section 14(4) provides that each Member to be appointed to serve in at least one County Assembly Committee and as well to comply with the County Assembly Standing Orders, and
- ii. Sections 9(e) provides that "A member of a county assembly shall— extend professional knowledge, experience or specialized knowledge to any issue for discussion in the county assembly.

Mr. Speaker,

During the last revision on membership to Committees, endeavors to address the perennial issues of Committees' quorum in both the Select and Sectoral Committees that has been commonly occasioned by excessive sharing of membership among other factors was not fully addressed. It has also been established that successful Committees sittings are almost impossible especially when all the Assembly Committees are scheduled to meet at the same time. This condition has been there despite the continued efforts by the Committee on Selection owing to the fact that the County Assembly has Twenty-two (22) Committees sharing sixty (60) Members of County Assembly. This is a state that may not fully be cured despite the Committees deliberate effort to address it.

Mr. Speaker,


In order to resolve the concerns emanating from the issues raised above and to ensure effective Committee service, the Committee did extensive consultations with the County Assembly Parties during a rigorous retreat exercise that took place at Mwingi 052 Leisure Resort to undertake re-constitution and revision of membership to the County Assembly Select and Sectoral Committees with effect from 11th to 15th December, 2025.

6.0 REVIEW OF COUNTY ASSEMBLY SELECT AND SECTORAL COMMITTEES' MEMBERSHIP.

Mr. Speaker Sir,

The establishment and operationalization of County Assembly Committees is anchored in the provisions of Section 14 of the County Governments Act, 2012, as read together with Standing Orders Nos. 152, 153, 154, 155 and 157 of the County Assembly, among other applicable statutes and procedural instruments. In this regard, the Committees presently in place were duly constituted in full compliance with the foregoing legal and procedural framework.

Notwithstanding such compliance, the Committee observes that the mere constitution of Committees in accordance with the law, though necessary, is not in itself sufficient to guarantee effective and efficient discharge of their mandates. Rather, the success and optimal performance of Committees is contingent upon a range of complementary factors which, when adequately addressed, significantly enhance institutional capacity, promote effective oversight and legislation, and ultimately contribute to the overall effectiveness and credibility of the Committee system within the County Assembly.

Mr. Speaker,

The Selection Committee, in the course of its duly scheduled meetings and in furtherance of its statutory and procedural mandate, has over time undertaken continuous assessment and evaluation of the performance of Committees. Such assessments have been guided by key parameters within the Committee purview that include Committee composition, attainment of quorum, and the capacity of Committees to convene and conduct their business regularly and effectively.

The Committee observes, as a generally accepted legislative principle, that the effectiveness of a Legislative Assembly is, to a large extent, dependent on the robustness, functionality, and productivity of its committee system. In this regard, the majority of County Assembly Committees have demonstrated commendable progress and a clear trajectory towards the effective discharge of their respective mandates. However, the

Committee further notes that a few Committees would benefit from targeted intervention and revitalization measures in order to re-energize their operations and enhance their overall effectiveness in the execution of their mandates.

Mr. Speaker,

Consequently, the Committee on Selection was compelled to undertake this exercise of reviewing the membership of certain Committees with a view to addressing the challenges and gaps identified hereinabove. This intervention was informed by the need to strengthen Committee functionality, enhance efficiency in the conduct of business, and ensure the effective discharge of the Assembly's legislative, oversight, and representative mandates.

In executing this mandate, the Committee placed significant reliance on the resolutions and consensus positions of the County Assembly political parties, which were articulated and justified on the basis of the following considerations:

- i. Mitigating factors that adversely affect the attainment and sustainability of quorum in Committees;
- ii. Embracing inter-party consultations and consensus-building as a foundation for meaningful and sustainable Committee reforms;
- iii. Ensuring alignment of Committee membership with political party affiliations in accordance with the principle of proportional representation;
- iv. Promoting fairness and equity in the distribution of Committee memberships among Members, subject to party strength and alignment, among other relevant considerations; and
- v. Upholding and enhancing gender representation within Committees in line with constitutional and statutory requirements.

Mr. Speaker,

In light of the foregoing considerations, the Committee on Selection is satisfied that the review of Committee membership was undertaken in a fair, consultative, and principled manner, guided by both the law and established parliamentary practice. The

Committee is further persuaded that the proposed adjustments are necessary and timely, and are aimed at reinforcing Committee effectiveness, inclusivity, and operational efficiency while preserving political balance and institutional harmony within the Assembly. Accordingly, the Committee is of the view that the measures proposed herein provide a sound and reasonable basis upon which the Assembly may consider and approve the ensuing recommendations in the interest of strengthening the Committee system and enhancing the overall performance of the County Assembly.











In conclusion, the Committee undertook this assignment guided by the Constitution, the Standing Orders of the Assembly, and the established practices governing committee membership and functionality. From the deliberations and observations made, it is evident that the review process was necessitated by practical considerations aimed at enhancing efficiency, ensuring quorum, promoting equitable representation, and strengthening inter-party cooperation within the committee system.

The Committee is satisfied that the approach adopted was consultative, objective, and anchored on the collective resolutions of the County Assembly Parties, with the overarching goal of enabling Committees to effectively discharge their

mandates. It is therefore the considered view of the Committee that the issues raised have been sufficiently addressed, thereby laying a firm basis upon which the Assembly may proceed to consider and adopt the final recommendations.


