### 3. Background

**Mr. Speaker,**

The Kitui County Supplementary Appropriation (No. 3) Bill, 2018 was submitted to the office of the Hon. Speaker on 5<sup>th</sup> June, 2018. During the County Assembly Sitting held on 6<sup>th</sup> June, 2018 (Morning Session), the Bill underwent the First Reading and was subsequently committed to the Budget and Appropriations Committee pursuant to the provisions of Standing Order 120.

**Mr. Speaker,**

The Kitui County Supplementary Appropriation (No. 3) Bill, 2018 was prepared in line with the approved Kitui County Third Supplementary Budget, 2017/2018 as provided under Standing Order 214(8). Owing to this, the Committee may make very few recommendations to the Bill.

In reviewing the Kitui County Supplementary Appropriation (No. 3) Bill, 2018, this committee utilized two Committee sitting held on 6<sup>th</sup> and 7<sup>th</sup> June, 2018 after its commitment to come up with this report.

5. Committee Highlights and consideration of the Kitui County Supplementary Appropriation (No. 3) Bill, 2018

Mr. Speaker,

The Kitui County Supplementary Appropriation (No. 3) Bill, 2018 submitted by the County Executive Committee Member for County Treasury was prepared in adherence to section 135 (6) of Public Finance Management Act, 2012 which states;

*“When the County Assembly has approved spending under subsection (2), a Supplementary Appropriations Bill shall be introduced for the appropriation of the money spent”*

It is therefore important then to note that this Bill was prepared in line with the County Third Supplementary Budget which was approved by the Assembly on 31<sup>st</sup> May, 2018 during the afternoon sitting.

Mr. Speaker,

The Committee held special sittings during the morning of 6<sup>th</sup> and 7<sup>th</sup> June, 2018 to consider the Bill and subsequently has come up with the recommendations to adopt the Bill without amendments as follows:
