#### 1.0 PREFACE

#### Mr. Speaker,

On behalf of the Members of the Budget and Appropriations (B&A) Committee, I hereby beg to present to this Honorable House, the Committee's Report on consideration of the Kitui County Emergency (KCE) Fund Bill, 2018 (County Assembly (C/A) Bill NO. 2, 2018).

Honorable members, the Public Finance Management Act (PFMA), 2012, is the national piece of legislation responsible in management of all public finances as envisaged by Article 224 of Chapter twelve of the Constitution on public finances. The County Governments' Emergency Fund which may be established and administered by a County Executive Committee Member (CECM) is contemplated in Section 110 of the (PFMA), 2012. In preparation of this report therefore, the Committee in addition to other references will majorly rely on this Act, the County Assembly Standing Orders as well as the recommendation made by the Members of public.

This Fund is established to cater for urgent and unforeseen need for which there is no legislative authority and shall be administered in accordance with the operational guidelines made under regulations approved by the Parliament and Law relating to disaster Management.

#### 5.0 BACKGROUND

#### Mr. Speaker,

The KCE Fund Bill, 2018 (C/A Bill NO. 2, 2018) seeks to provide payments for unforeseen needs for expenditure which cannot be delayed to the next financial year. It further provides for payments for the need for expenditures to alleviate damage, loss, hardship or suffering of Kitui county residents that may be caused by unforeseen events such as a drought, fire, floods, storm, or outbreak of disease, among others.

This bill was introduced in the House through the First reading during a sitting held on 24<sup>th</sup> April, 2018 and subsequently committed to the Committee on B&A.

Pursuant to the provisions of Article 196 of the Constitution and Standing Orders No.120, the Committee on B&A organized and facilitated public participation exercise in two designated Centres being Kitui Multipurpose Hall and Mwingi Resource Centre on 10<sup>th</sup> May, 2018 as earlier advertised in electronic and print media on 4<sup>th</sup> and 9<sup>th</sup> May, 2018. This exercise was conducted to ensure members of public makes their input to this vital piece of legislation and as required by the law.

To this end and pursuant to Standing Order 123 on sequence of consideration of a Bill, this Committee hereby proposes the following recommendations to this House:-

# 9.0 CLAUSES WITHOUT AMENDMENTS

Clause 3, 4, 7, 8, 9, 10 and 11

The committee was satisfied with the provisions of the above clauses and thus proposes them to be part of the Bill as printed.

# 10.0 CLAUSES WITH AMENDMENTS

Clause 5

That clause 5 to be amended by deleting the words "this Act" at the end of sub clause 5(1) and inserting the following words a framework and criteria approved by the county assembly

Clause 6

That clause 6 to be amended by rephrasing the whole Clause as follows

6 (1) The County Executive Committee Member may make payments from the county government's Emergency Fund only if he or she is satisfied that there is an urgent and unforeseen need for expenditure for which there is no legislative authority and shall be in accordance with operational guidelines made under regulations approved by Parliament and the law relating to disaster management.

# 14.0 CONCLUSION

#### Mr. Speaker,

In conclusion, the Committee's plea to the Assembly is to approve the Bill as amended in this report. There are some emergency cases already faced by the county residents resulting from the heavy downpour experienced in the last two months which cannot be address in absence of this law. It is therefore important that the members of Assembly gives priority in enactment of this Bill.
