## 1.1 MANDATE OF THE COMMITTEE

## Mr. Speaker Sir,

The mandate of the committee on appointments is stipulated in Standing Order No. 184 which states inter alia: -

1) There shall be a select Committee to be designated the Committee on Appointments to be appointed by the County Assembly, consisting of the Speaker as a Chairperson, the Leader of the Majority Party, the Leader of the Minority Party and not more than three other members nominated by the County Assembly Business Committee, on the basis of proportional Party Membership in the County Assembly, taking into consideration the numerical strength of the Parties and interests of Independent Members. 2) The Committee on Appointments shall consider for approval by the County Assembly appointments under articles 179(2) (Members of County Executive Committees).

## 2.0 BACKGROUND INFORMATION 2.1 COMMITTAL OF NOMINEES TO THE COMMITTEE

On 14<sup>th</sup> March, 2018 the Speaker of the County Assembly in his communication to the House and Pursuant to the provision of standing Order No. 39(1) informed honorable members that he had received a list of thirteen nominees for the positions of County Chief Officers from Her excellency the Governor. He further, referred the names to the relevant sectoral and select committees for vetting and table a report in the house within 21 days as provided for in section 9(1) of the Public Appointments (County Assemblies Approval) Act No.5 of 2017.

## 2.2 THE ESTABLISHMENT OF THE OFFICE OF THE CHIEF OFFICER

Section 45 of the County Governments Act, 2012 inter alia provides that:

The governor shall:

- 1) Nominate qualified and experienced county chief officers from among persons competitively sourced and recommended by the county public service board, and
- 2) With the approval of the county assembly, appoint chief officers.

## 2.3 FUNCTIONS OF THE CHIEF OFFICER

- 1) A county chief officer shall be responsible to respective county executive Member for the county department as provided under section 46 of the county government act, 2012
- 2) The county chief officer shall be authorized officer in respect of exercise of delegated authority.

## 2.4 NOTIFICATION TO THE NOMINEES AND THE PUBLIC

The Clerk of the county assembly on 15<sup>th</sup> March, 2018 invited the nominees on behalf of the Committee vide a print media advert in the local dailies, inviting the Nominees to appear before the Committee for vetting and further informing the public on the time, date and place for holding the approval hearings as provided for in Section 7(4) and 7 (10) of Public Appointments (County Assemblies Approval) Act No.5 of 2017.

The clerk further requested the public to submit memoranda challenging the suitability or otherwise of the candidates by close of business on 20<sup>th</sup> March, 2018. He further instructed the nominees to present their clearance certificates from the relevant statutory bodies.

#### 2.5 SUBMISSION OF MEMORANDA

By the close of business on 20<sup>th</sup> March, 2018 the office of the Clerk had not received any memoranda from the public challenging the suitability or otherwise of the Nominees.

#### 2.6 COMMITTEE PROCEEDINGS

The committee held two sittings on 23<sup>rd</sup> March, 2018 in Committee Room 2 in the Assembly precincts. The committee's first business was formulate Questions after unanimously agreed that 60% was the average pass mark for both Nominees.

The committee considered public views, examined the nominees' curriculum vitaes and testimonials, filled questionnaires and clearance certificates.

## **3.0 VETTING OF THE NOMINEES**

In conducting the vetting, the committee examined the nominees against the following criteria, amongst others, as set out in the Public Appointments (County Assemblies' approval) Act, no. 5 of 2017.

The committee considered the following:

- i. Academic qualifications
- ii. Employment record
- iii. Professional affiliations
- iv. Potential conflict of interest
- v. Knowledge of the relevant subject
- vi. Overall suitability for the position
- vii. Integrity
- viii. Vision and leadership
- ix. Expectations and key priorities

Section 8 of the Public Appointments (County Assemblies Approval) Act, 2017, provides that;

The issues for consideration during vetting shall be: -

- a) The procedure used to arrive at the nominee.
- b) any constitutional or statutory requirements relating to the office in question; and
- c) The suitability of the nominee for appointment proposed having regard to whether the nominee's credentials, abilities, experience and qualities meet the needs of the body to which nomination is being made.

The office of the Clerk received the above information in compliance with section 8 on 22<sup>nd</sup> March, 2018 and the same was forwarded to the committee.

## 4.0 COMMITTEE OBSERVATIONS AND FINDINGS

4.1 Mr. Clement Mulyungi Munyithya- Nominee for appointment as County Chief Officer, office of the Governor Department of Administration and Coordination of County Affairs.

- 5. That the nominee understands clearly the five pillars contained in the manifesto of Her Excellency the Governor.

- 1. Mr. Clement Mulyungi Munyithya as County Chief Officer, office of the Governor Department Of Administration and Coordination of County Affair and;
- 2. M/s. Agnes Kawila Mulewa as County Chief Officer, office of the Governor.
