Honorable Members,

Standing order 151 (1) (d) provides that;

(1) There shall be a select committee, to be designated the County Assembly Business Committee, consisting of;

(d) not less than eleven and not more than seventeen members, who shall be nominated by County Assembly parties and approved by the County Assembly at the commencement of every Session, reflecting the relative majorities of the seats held by each of the County Assembly parties in the

County Assembly and taking into consideration the interests of Independents.

Further, standing order 151 (7) provides that,

‘If, for any reason, a member of the County Assembly Business Committee is unable to attend, the Leader in the County Assembly of the party which nominated that Member may, with the concurrence of the Speaker, appoint another Member in that Member’s place for the period for which the Member is unable to attend.

Honourable Phillip Nguli was concerned that in view of standing order 151 (7), no party is responsible for dealing with independent members who failed to attend the County Assembly Business Committee.

A County Assembly Party is defined under Standing Order 2 as a party or coalition of parties consisting of not less than five percent of the membership of the County Assembly. Independent members do not belong to any party.

They can only be nominated to be members of the County Assembly Business Committee by either the Majority Party or the Minority Party.

Therefore, it will be the responsibility of the party which nominated the independent member to the County Assembly Business Committee to appoint another member in his/her stead. Thank you.
