In order to resolve the menace evolving on committed membership and in consideration of the fact that assemblies are guided nonetheless but best practices on customs and traditions, the committee of selection in one of its meetings, reviewed the committee membership I and agreed to carry out an exercise on realignment of committees soone possible.

#### 3.0 COMMITTEE MANDATE

#### Mr. Speaker Sir,

The committee's mandate, functions and limitations are stipulated in Standing Orders No's.152, 153, 154, 155, 156 and 157, that the Committee on Selection shall;

- Nominate members to Select and to Sectoral Committees save for the membership of the County Assembly Business Committee and Committee on Appointments. This shall be done in consultation with the County Assembly parties;
- give consideration to the need for gender balance and shall so far as may be practicable, ensure that no more than two-thirds of Members of a Committee of the County Assembly, including a committee established through a resolution of the County Assembly, shall be of the same gender;
- ensure that the membership of each committee reflects the relative majorities of the seats held by each of the County Assembly parties in the County Assembly;

- Except as the County Assembly may otherwise resolve, on recommendation of the committee on Selection for reasons to stated, no member shall be appointed to serve in more than the Sectoral committees;
- Within seven days upon nomination of members to serve in a committee of the County Assembly, present the list to the County Assembly for approval.

#### 6.0 INTRODUCTION.

#### Mr. Speaker Sir,

The review of the committee membership was occasioned by an outcry some members, on the disproportionate allocation of committees whe disadvantaged the said members. Subsequently, selection commit members unanimously agreed on the need to review the commit membership to cure the outcry based on the proposed formula of snar out committee positions which was agreed on by Members of Court Assembly at a "kamukunji".

The proposed formula of sharing out committee positions is as snow below,

Thirteen (13) member committee:-

- Wiper Party -9 slots
- Narc Party 3 slots
- Jubilee Party-1 slot

#### Eleven (11) member committee:-

- Wiper Party -6 slots
- Narc Party 2 slots

Mr. Speaker Sir,

It is important to note that the proposed formula was also used to reconstitute the three select County Assembly committees namely; County Assembly Business Committee, Public Investments and Accounts committee and Budget and Appropriations Committee.

It is on this premise that the committee retreated to Pride Inn-Paradise Mombasa on 21st to 26th September, 2020 to deliberate on the committees membership with a view to review it.

#### Mr. Speaker Sir,

The committee during its sitting on 23rd September 2020, minority party (NARC) members cited the proposed formula on committees' composition was unfair. The minority party members opined that the exercise on realignment of committees should be deferred for further consultation. For that reason, committee members proposed that a vote be taken to determine whether to proceed or completely adjourn the exercise and head back to Kitui. Resultantly, consensus was not reached and members of the minority party (NARC) walked out of the exercise alluding that the process was not promoting fairness hence cannot participate in such an exercise. Members felt that minority party- (NARC) walkout was in bad faith since constitution of committees is based on the strength of parties and the same proposed formula had earlier on been applied in reconstituting the three select County Assembly committees namely; County Assembly Business Committee, Public Investments and Accounts committee and Budget and Appropriations Committee.

#### Mr. Speaker Sir,

Nevertheless, in accordance to the provisions of Standing Orders 158(b), the committee members unanimously agreed to proceed with meeting since quorum was present and did not have the luxury of time its end.

The committee noted that by the time of completing this report, minority party- (NARC) had neither presented their dissenting opinion(s) the committee nor submitted a list of nominees to serve in the respect County Assembly's sectoral and select committees.

Nomination of members to committees is executed by County Assemble parties and a member shall not be a member of a committee of the count

Assembly, unless the nomination of such Member into the committee is approved by the County Assembly.
