#### **PREFACE**

#### Hon. Members,

On behalf of the Committee on Powers and Privileges, I wish to present to this House the Report of the Committee on Powers and Privileges on the inquiry into the alleged absenteeism from County Assembly plenary sittings by the Member of County Assembly, Matinyani Ward- Hon. Sylvester M. Kitheka.

#### Mandate of the Committee

Section 15(4) of the County Assemblies Powers and Privileges Act (CAPPA) states that the functions of the Committee on Powers and Privileges shall be to:

- a) Inquire into the conduct of a Member whose conduct is alleged to constitute a breach of privilege in terms of section 16;
- b) Perform such other functions as may be specified in this Act.

#### **Background** information

On 24<sup>th</sup> November, 2020 during the morning sitting, the Speaker made a communication on failure to attend County Assembly sittings. In his

communication, he stated that it had come to his attention that Hon. Sylvester Munyalo Kitheka, M.C.A.- Matinyani Ward missed fourteen (14) consecutive sittings covering the period from 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020, contrary to Article 194(1)(b) of the Constitution as read together with Standing Order 229(1). He directed the Committee on Powers and Privileges to inquire into the matter within the stipulated timelines and submit a report to the House.

#### **Sittings**

The Committee held two (2) sittings on 3<sup>rd</sup> December, 2020 to receive evidence from Hon Sylvester M. Kitheka and other parties. Thereafter, the Committee retreated to Thatha Hills Resort Machakos on 4<sup>th</sup>, 5<sup>th</sup> and 7<sup>th</sup> December 2020, and Lysak Haven Hotel Machakos on 6<sup>th</sup> December, 2020 to compile this report.

#### Acknowledgement

I wish to record the Committee's gratitude to the House, for having entrusted the Committee with this important task. The Committee thanks all parties who honoured invitations to appear before it and is also thankful to the Office of the Speaker and Clerk of Assembly for the support accorded during the inquiry.

It is therefore my pleasant duty and privilege on behalf of the Committee of Privileges, to table this Report.

#### **LEGAL FRAMEWORK**

#### **The Constitution**

#### Hon. Members,

Article 194(1)(b) of the Constitution states that the office of a Member of a County Assembly becomes vacant if the Member is absent from eight sittings of the Assembly without permission, in writing, of the Speaker of the Assembly, and is unable to offer satisfactory explanation for the absence.

Article 195 of the Constitution gives the County Assembly or any of its Committees power to summon any person to appear before it for the purpose of giving evidence or providing information.

#### The County Assemblies Powers and Privileges Act (CAPPA)

Section 16 of the CAPPA states that the Committee of Powers and Privileges may find a Member to be in breach of privilege if the Member amongst others:

- i) willfully fails or refuses to obey any rule, order, or resolution of a County Assembly;
- conducts himself or herself in a manner which, in the opinion of the Committee on Powers and Privileges, is intended or is likely to reflect adversely on the dignity or integrity of a County Assembly or its Members or to be contrary to the best interests of a County Assembly or its Members.

Section 18 of the CAPPA empowers a County Assembly or its committees to summon any person to appear before it for the purpose of giving evidence or providing any information, book, record or document under their control.

#### **The County Assembly Standing Orders**

Standing Order No. 229 provides as follows:

- (1) If during any session, a Member is absent from eight sittings of the County Assembly without permission, in writing from the Speaker, the Speaker shall report the matter to the County Assembly and the matter shall stand referred to the Committee of Privileges for hearing and determination.
- (2) The Committee of Privileges shall inquire into a matter referred to it under paragraph (1) within fourteen (14) days from the date the matter is referred to it and shall thereupon submit a report to the County Assembly.
- (3) If the report finds that the Member has offered, a satisfactory for the Member's absence from eight (8) sittings of the County Assembly without permission in writing from the Speaker, there shall be no further proceedings in the County Assembly in respect of the matter.
- (4) If the Report of the Committee finds that the Member has not offered a satisfactory explanation for the Member's absence from eight (8) sittings of the County Assembly under paragraph (1), the Chairperson of the Committee or a member of the Committee designated by the Committee for that purpose shall, upon submitting the report, give a three (3) day's notice of Motion "This County Assembly notes the Report of the Committee of Privileges laid on the Table of the County Assembly on.... regarding ....."
- (5) A Motion under paragraph (4) shall be debated in the usual manner of debating Motions, except that-
  - (a) no amendment shall be permitted to the Motion;
  - (b) the debate of the Motion shall not be anticipated by a Motion for the adjournment of the County Assembly, and no dilatory Motion shall be moved in relation to the business, and the business shall not be interrupted under any Standing Order.
- (6) At the conclusion of the debate on a Motion under paragraph (4), the Speaker shall not put a question but shall declare that, pursuant to Article 103(1)(b) of the Constitution, the office of the Member concerned has become vacant.

# THE INQUIRY, TERMS OF REFERENCE, WITNESSES AND REVIEW OF DOCUMENTS

#### Terms of Reference

#### Hon. Members,

In order to undertake this task, the Committee summarized its Terms of Reference as follows:

- i) To inquire into whether Hon. Sylvester M. Kitheka missed eight (8) sittings without the Speaker's written permission contrary to Article 194(1)(b) of the Constitution as read together with Standing Order No. 229 during the period from 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020;
- ii) To inquire into whether Hon. Sylvester M. Kitheka offered a satisfactory explanation for his absence, in line with Article 194(1)(b) of the Constitution, should the allegation be found to be substantiated;
- iii) What sanctions apply/ recommendations to the House on appropriate action on the matter under consideration.

#### Witnesses

The Committee took evidence from the following persons:

- Hon. Sylvester M. Kitheka on the basis that he was accused of having missed eight (8) during the period from 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020.
- 2. Mr. Fred Kitheka, Warden II as he was the Serjeant at Arms in charge of the attendance register on 6<sup>th</sup> October, 2020.
- 3. Mr. Cosmus Ngumbi, Warden III as he was the Serjeant at Arms in charge of the attendance register on 21<sup>st</sup> October, 2020.

#### Documentary evidence

The Committee relied on the following documents in its inquiry:

- 1. The Speaker's Communication dated 24th November, 2020.
- 2. Hon. Sylvester M. Kitheka's letter to the Speaker dated 7<sup>th</sup> December, 2020 on request for information on failure to attend County Assembly sittings.
- 3. Plenary attendance registers for the period 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020.
- 4. Mr. Lawrence Kirigwi's (Senior Serjeant at Arms) letter dated 3<sup>rd</sup> December, 2020 to the Chairperson, Committee on Powers and Privileges on the attendance of Hon. Sylvester M. Kitheka.
- 5. Response by Mr. Kevin Ndeto- Senior I.C.T. officer on the CCTV footage for the period under consideration. The letter stated that the Network Video Recorder (NVR) can access footage from only the previous 22 days and as such, the Committee was unable to review footage for the period under consideration to ascertain whether the Honourable Member attended County Assembly sittings or not. This is a serious loophole that can be exploited malicious people and as such the Committee recommends that the Assembly management looks into this for improved security.
- 6. Motor vehicle register at the gate which records all motor vehicles entering the Assembly precincts. It was noted that Hon. Sylvester M. Kitheka's motor vehicle registration number was not recorded during the period under consideration though it is possible for a Member to be given a lift, walk or use public means. The Committee recommends that it would be good practice for Members to sign an attendance register at the gate.
- 7. Payment schedule for the period under consideration. The Committee reviewed this schedule to ascertain whether the Member was paid his sitting allowances for the period in question which would prove presence or absence from the County Assembly.

#### **EVIDENCE RECEIVED FROM THE WITNESSES**

#### HON. SYLVESTER M. KITHEKA, M.C.A. MATINYANI WARD

#### Hon. Members,

The Hon. Member appeared before the Committee on 3<sup>rd</sup> December, 2020 and submitted that:

- 1. The allegation that he did not attend eight (8) sittings during the period under consideration is not true.
- 2. According to him, eight (8) sittings should start from the last day he was present. Therefore, though the period under consideration begins on 30<sup>th</sup> September, 2020, the Committee should note that on 29<sup>th</sup> September, 2020, he was present as per the attendance register and therefore the period of his absence should begin from 28<sup>th</sup> September 2020.
- 3. Regarding the period he is accused of being absent:
  - i) On 30<sup>th</sup> September, 2020, he confirmed that he did not attend both the morning and afternoon sittings;
  - ii) On 1<sup>st</sup> October, 2020, he confirmed that he did not attend both morning and afternoon sittings;
  - iii) On 6<sup>th</sup> October, 2020, he attended both sittings but his name was cancelled in the attendance register;
  - iv) On 7<sup>th</sup> October, 2020, he confirmed that he did not attend both the morning and afternoon sittings;
  - v) On 13<sup>th</sup> October, 2020, he did not attend both sittings;
  - vi) On 14th October, 2020, he did not attend both sittings;
  - vii) On 21<sup>st</sup> October, 2020 he attended both sittings but his name was crossed out/ cancelled in the attendance register.
- 4. It is well-known that he has been living with diabetes since he was in class five at the age eleven years and as a result is under medication and therefore unable to sit through a whole afternoon plenary session. On 30<sup>th</sup> September, 2020, 13<sup>th</sup> and 14<sup>th</sup> October, 2020 he was in hospital and if given time can substantiate this.
- 5. On 24<sup>th</sup> November, 2020 when the Speaker made the Communication from the Chair on the failure to attend sittings, he (Hon. Munyalo) acknowledges that he over reacted in the House and apologizes for this.

- 6. While Standing Order 229 talks about County Assembly sittings, he cannot verify everything about signing and attending the sittings or signing and leaving and if called upon, he will avail a specimen signature or passport for purposes of verifying his signature.
- 7. The allegations are false, politically motivated and fabricated to paint him negatively that he does not represent the residents of Matinyani.
- 8. He requested the Committee to:
  - i) Inquire into why his signatures for four sittings held on 6<sup>th</sup> and 21<sup>st</sup> October, 2020 were cancelled/ crossed out as he does not know why this was done;
  - ii) Confirm if he attended any online meetings or meetings outside the Assembly during the period under consideration;
  - iii) Not be guided by politics in making the final decision.

It is pertinent to note that during this meeting, the Speaker/ Chairperson of the Committee stated that he did not give Hon. Sylvester M. Kitheka permission to be absent from the Assembly.

#### MR. SIMEON MALUKI- SERJEANT AT ARMS

Mr Simeon Maluki appeared before the Committee on 3rd December, 2020 to represent the Serjeant at Arms Department.

#### He stated as follows:

- 1. On any sitting day, the Serjeant at Arms on duty is in-charge of the attendance register outside the chamber. As members proceed to the Chamber, they sign the register confirm/ their presence. The Serjeant will go through the register and cancel/ cross out all unsigned names. In situations whereby a Member is signed for, a memo is written to the Clerk detailing the Member(s) who signed for Member(s) not present.
- 2. On 6<sup>th</sup> October, 2020 Mr. Fred Kitheka Warden II was on duty and confirmed that he did not see Hon. Sylvester Munyalo. As is practice, he crossed out cancelled his name to show that he was not present.
- 3. On 21<sup>st</sup> October, 2020 Mr. Cosmus Ngumbi Warden III was on duty and confirmed that he did not see Hon. Sylvester Munyalo and as is practice, he crossed out/ cancelled his name to show that he was not present.

#### MR. FRED KITHEKA- WARDEN II

He appeared before the Committee on 4th December, 2020 and submitted that:

- On any day that he is the officer in charge of the attendance register, he
  is expected to be its custodian and know which Honourable Members
  who were present and those who were not.
- 2. Currently, for any Member who does not come to the Assembly, they cross out the name and if a Member signs for another, they also note this.
- 3. If a Member wants to sign to sign for another, they inform them not to do so, but if they insist, they let the Member sign and inform the Senior Seajeant at Arms and then the names are crossed out. Before, they used to have a book recording Members who sign for others but currently, they just cross out the names.
- 4. On 6<sup>th</sup> October, 2020, he was the officer in charge of the attendance register and Hon. Sylvester Munyalo did not come to the Assembly. Hon. James Wangunze signed for him, despite being requested not to. Therefore he crossed out/ cancelled his name as confirmation that the Honourable Member was not present.
- Currently, the department does not have a black book to note such incidents, however, there is a gate register whereby all Members motor vehicles within the Assembly precincts on any given day are recorded.

Through telephone communication, Hon. James Wangunze denied the allegation that he signed for Hon. Sylvester M. Kitheka on 6<sup>th</sup> October, 2020.

#### MR. COSMAS NGUMBI- WARDEN III

He appeared before the Committee on 4th December, 2020 and stated that:

- 1. He usually gets the attendance register from the Clerk's secretary and is expected to ensure that every Member signs for himself/ herself and if a Member signs for another, he is makes a mark on the register.
- 2. If a Member has not come to the Assembly, they cross out the name in the register to avoid signing in future and once they are done with the sitting's activities, they sign the register and take it to the Serjeant at Arms and it is forwarded to the Clerk.
- 3. On 21<sup>st</sup> October, 2020 Hon. Sylvester M. Kitheka did not come to the Assembly and it was Hon. Kasee Musya signed for him. Hon. Kasee signed against his own name, went into the chamber, then came back and signed against Hon. Sylvester's name.
  - Therefore he crossed out/ cancelled his name to confirm his absence.
- 4. Though they should not allow Members to sign for their colleagues, they cannot argue with them, therefore they just request them not to do so, but let them sign if they insist. Initially, they used to have a book indicating when a Member signs for another but currently, they just cross out/ cancel the name and indicate absent.

Through telephone communication, Hon. Kasee Musya denied the allegation he signed for the Hon. Member on the day in question 21st October, 2020.

#### PAYMENT OF SITTING ALLLOWANCES

#### Hon. Members,

Noting that sitting allowance payments are prepared and paid in weeks, the Committee reviewed the plenary sittings payment schedules for the period under consideration and noted as follows:

- i) Week of 28<sup>th</sup> September- 2<sup>nd</sup> October, 2020: Hon. Munyalo was only paid 2 sittings allowances for 29<sup>th</sup> September, 2020;
- ii) Week of 5<sup>th</sup> 9<sup>th</sup> October, 2020: he was not paid;
- iii) Week of 12th- 16th October, 2020: he was not paid;
- iv) Week of 19th 23rd October, 2020: he was not paid;

The above trend therefore indicates that he was not in attendance during the period under consideration.

#### **ISSUES FOR DETERMINATION**

#### Hon. Members,

The Committee established the issues for determination as:

- i) Whether Hon. Sylvester M. Kitheka missed eight (8) sittings without the Speaker's written permission contrary to Article 194(1)(b) of the Constitution as read together with Standing Order No. 229 during the period from 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020;
- ii) Whether Hon. Sylvester M. Kitheka offered a satisfactory explanation for his absence as required by Article 194(1)(b) of the Constitution as read together with Standing Order 229(3), should the allegation be found to be substantiated;
- iii) What sanctions apply/ recommendations to the House on appropriate action on the matter under consideration.

### ANALYSIS OF EVIDENCE, OBSERVATIONS AND FINDINGS

#### Hon. Members,

The Committee analyzed the evidence and made the following observations:

- i) Whether Hon. Sylvester M. Kitheka missed eight (8) sittings without the Speaker's written permission contrary to Article 194(1)(b) of the Constitution as read together with Standing Order No. 229 during the period from 30<sup>th</sup> September, 2020 to 21<sup>st</sup> October, 2020;
  - 1. When the Honourable Member appeared before the Committee on 3<sup>rd</sup> December, 2020, he stated that while it is true that he did not attend County Assembly sittings on 30<sup>th</sup> September 2020, 1<sup>st</sup>, 7<sup>th</sup> and 14<sup>th</sup> of October 2020, the allegation that he was absent on 6<sup>th</sup> and 21<sup>st</sup> October 2020 is not true.
  - 2. However, vide a letter to the Speaker dated 7<sup>th</sup> December, 2020 and addressed to the Chairperson, Committee on Powers and Privileges he admitted that he did not attend County Assembly sittings during the period under consideration (Annex 3).

The Committee notes that when the Honourable Member appeared before it on 3<sup>rd</sup> December, 2020, he misled it and provided false information by alleging that he attended the County Assembly sittings on 6<sup>th</sup> and 21<sup>st</sup> October, 2020. He also made similar allegations on 24<sup>th</sup> November, 2020 on the floor of the House after the Speaker made his communication on failure to attend County Assembly sittings.

Section 27(3)(g) of the CAPPA provides that a person commits an offence if they willfully furnish a County Assembly or a committee with information which is false or misleading or makes a statement before a County Assembly or a committee that is false or misleading.

The Committee will therefore on its own motion as mandated by section 15(5) of the CAPPA, conduct an inquiry into this apparent breach of privilege with a view of making appropriate recommendations prescribing suitable sanctions on the matter and subsequently table a report for consideration by the House.

- 3. During the meeting held on 3<sup>rd</sup> December, 2020, the Speaker/ Chairperson of the Committee stated that he did not give the Member permission to be absent from the County Assembly.
- 4. The attendance registers for the period under consideration also indicate that the Member did not attend County Assembly sittings as his name has been crossed out/cancelled on all attendance registers for the period under review (Annex 4(a)- (n)).
- 5. The Serjeants at Arms on duty on the two (2) contentious days when Hon. Sylvester M. Kitheka initially insisted that he was present confirmed to the Committee that the Honourable Member was actually absent and this was the reason as to why his name had been crossed out/ cancelled out in the attendance registers.
- 6. Vide a letter dated 3<sup>rd</sup> December, 2020, the Senior Serjeant at Arms informed the Committee that Hon. Sylvester M. Kitheka was not present during the period under consideration and those who signed for him were not known. (Annex 5).
- 7. The payment schedules for the period under consideration clearly indicate that he was not paid his sitting allowances which is evidence that he was absent from the Assembly sittings under review.

Based on the above findings and observations, the Committee resolved that the allegation that Hon. Sylvester M. Kitheka missed eight (8) sittings without the Speaker's written permission contrary to Article 194(1)(b) and Standing Order 229(1) during the period under consideration was SUBSTANTIATED.

ii) Whether Hon. Sylvester M. Kitheka offered a satisfactory explanation for his absence as required by Article 194(1)(b) of the Constitution read together with Standing Order 229(3), should the allegation be found to be substantiated;

#### Hon. Members,

Article 194(1)(b) of the Constitution as read together with Standing Order 229 require that a Member should not be absent from eight (8) sittings of the Assembly without permission, in writing, of the Speaker of the Assembly.

However, the same legal provisions recognize that a Member may offer satisfactory explanation for the absence.

#### The Committee noted that:

- 1. Vide his letter dated 7<sup>th</sup> December, 2020 and addressed to the Chairperson, Committee on Powers and Privileges (Annex 3), Hon. Sylvester M. Kitheka stated, in writing, that he could not attend Assembly sessions as he had personal pressing issues which took part of his time and energy. The said issues made him not have peace of mind for him and his family amongst other reasons for his absence as outlined in the letter. He further offered his apology to the Speaker for failure to inform him of his absence and made various prayers.
- 2. During his oral submissions to the Committee on 3<sup>rd</sup> December, 2020, he informed the Committee that he is diabetic and has been under treatment since he was in class five at the age of eleven years. (Annex 6).

Based on this, the Committee resolved that he had offered a satisfactory explanation for his absence from eight (8) sittings of the County Assembly as required by Article 194(1)(b) of the Constitution read together with Standing Order 229(3).

iii) What sanctions apply/ recommendations to the House on appropriate action on the matter under consideration.

Standing Order 229(3) states that:

"If the report of the Committee finds that the Member has offered a satisfactory explanation for the Member's absence from eight sittings of the County Assembly without the permission in writing from the Speaker, there shall be no further proceedings in the County Assembly in respect of the matter."

The Committee found that Hon. Sylvester M. Kitheka had offered a satisfactory explanation for his absence from the County Assembly during the period under consideration, particularly noting the contents of his letter dated 7<sup>th</sup> December, 2020 addressed to the Speaker. Therefore, there should be no further proceedings in the House on the matter.
