COMMITTEE ON FINANCE AND PLANNING STATUS REPORT ON THE FINANCE BILL, 2019.

Mr. Speaker,

Part IV of the Public Finance Management Act, 2012 outlines the County Government Responsibilities with respect to the management and control of public finance. As guided by Section 133 of this Act and the Standing Orders, the County Governments are required under this section to approve a Finance Bill within a period of ninety days after passing the Appropriation Bill.

In adherence to the above provisions, the County Executive Committee Member, County Treasury published the Kitui County Finance Bill, 2019 on 7th January, 2020 and submitted it to the County Assembly on 27th January, 2020 for consideration and approval.

Mr. Speaker,

Standing Order 110 on the introduction of Bills to the Assembly in sub section (6) provides that;

“A Bill shall be signed by the Member in charge of it and shall be introduced by way of First Reading in accordance with Standing Order 119 (First Reading of Bills)”.

Mr. Speaker,

In adherence to the above provisions, the Kitui County Finance Bill, 2019 was read a first time during a sitting held on 25th February, 2020 in the afternoon sitting. Subsequently the Bill was committed to the Committee on Finance and Planning pursuant to the provisions of Standing Order 217 for consideration, public participation, preparation and presentation of a committee report before the House.

Mr. Speaker,

The County Assembly Standing Orders 120 (3) provides that the Committee to which a Bill is committed has the responsibility to facilitate public participation to collect public views and recommendations when making a report to the County Assembly. As a result therefore, the committee came up with a program to allow the residents of the entire

County have an opportunity to air their views on the Bill. A public participation program therefore was developed to cover the whole County by Sub Counties sharing the centers as can be seen Annexed hereto (Annex I). This program was also uploaded onto the Kitui County Assembly website and also advertised in the electronic and print media.

However, Mr. Speaker the scheduled event did not take place due to the confirmation of the first case of Covid -19 in Kenya on 13th March, 2020 which led to a ban of Public gatherings by His Excellency the President.

The Assembly went ahead to cancel the advertisement in adherence to the regulations issued by the Government on prevention of the spread of Corona Virus. The cancellation is attached as (Annex II)

Mr. Speaker,

It is the considered opinion of the committee on Finance and Planning that Finance Bills involves taxation which directly affects the day to day running of Government economies and as such the document has to be submitted to the people of Kitui. The committee thus came to consensus that the same can be conducted through advertising for the submission of memoranda to the County Assembly or through the Members of County Assembly by the stakeholders and the general public so as to ensure that the due procedure of the law is fully adhered to.

Mr. Speaker.

In lieu of the above, this committee is not able to table a report before the house without the mandatory input of the public and thus requests for more time from the chair to enable it table a report.

Petitioner opposes TSC nominee over birthplace

Says Leila Ali shouldn't be a commission member and she is unfit to represent region 'as she was not born there'

A voter in Mandera has opposed the nomination of Leila Ali as a member of the Teachers Service Commission. Ali Maalini argues that the candidate has a questionable educational background. He further claims the candidate is not a resident of any of the Northeastern counties — Mandera, Garissa, Marsabit and Wajir. The nominee's identity card shows that she was born in Mogadishu, Somalia, in 1979. The Education Committee chaired by Member of Parliament Julius Nelly on Thursday, said she was fit to be vetted but Maalini argues she is unfit to represent the region. In her response, Leila said she is

born of a Kenyan mother who delivered while on a trip to Somalia. "My grandfather Ali Kabani was a freedom fighter and was Thika mayor for 40 years. He was remarkably honored for his efforts in the fight for freedom," Leila said. She says she was raised in Lortokok and went to DEB Primary School, Lortokok. Leila says she lost her parents at seven years and had challenges accessing education. "Our community did not value girl's education," she said. "I had teachers who were supportive and gave evidence that I went through school," she said. The committee requested her to bring documentation of her parents' citizenship. She has dual citizenship — British and Kenyan. Leila says she is a graduate of UK's Leicester University. "My early life

experiences birthed my desire to promote education." She is currently a senior lecturer at Becker Merah and once served as a revenue officer at Kenya Revenue

Authority. She is also involved in an NGO in Kajiado which places girls in schools. Leila also chairs an anti-corruption committee at the Education Authority.



Wajir prepares to reduce salt content in borehole water

STEPHEN ASTARRO/Amor The Wajir Water department is conducting feasibility studies in Wajir North, South, West, East, Eldas and Tarsaj in a bid to desalinate water. The project will be done in partnership with Boreal Water Company and World Vision. The department intends to pilot desalination in two boreholes in each of the six subcounties using reverse osmosis. It's technical team, led by executive Elba Bashir, set off for the field on Wednesday to collect water samples. Bashir said desalination machines will be commissioned after chemical and biological tests are carried out. "The department has identified two water supply points in each subcounty, namely Barder and Dift in Wajir South, Hadado borehole 1 and Shandara in Wajir West and Qarsa Jugola and War Atey in Eldas," he said. Other boreholes are Eiba and Boji-Garas in Wajir East, Dambab and Hosieta in Wajir North and Burmayo and Dambab in Tarsaj.

Ban on weddings, funerals, discos enforced in North Rift

Parents told to keep children indoors, no outdoor play with friends or visits

No big funerals, no big weddings allowed, no discos and disco matangs, no children playing outdoors, no big meetings and church services must not be overcrowded.

That's the situation in East Usukuma county as it takes measures to prevent the spread of the coronavirus, known as Covid-19, so far.

Mat Teaching and Referral Hospital will screen everyone entering and all patients.

Governor Jackson Mandago, during a meeting on preventing Covid-19, took the security committee through a long list of safety measures.

Schools are closed around the county and Mandago said parents should ensure they keep their children strictly at home and don't let them go out to play or visit areas

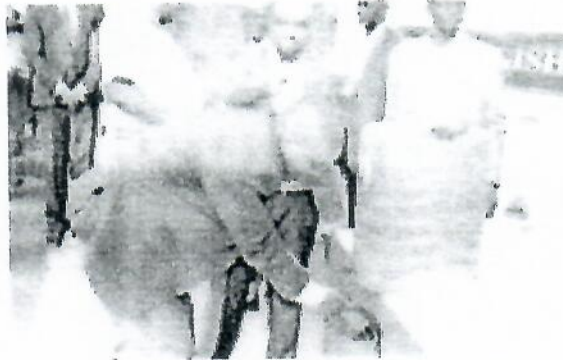
where they might be exposed. Markets will not be closed and public health officers will be deployed to help sanitation measures and prevent overcrowding. People should be at least a metre apart.

The government is also enforcing a ban on attending big funerals, weddings and other big events and ceremonies in the North Rift.

County commissioners have directed chiefs and ward officers to ensure funerals and weddings are strictly private family affairs for the next month until the situation is reviewed.

East Usukuma county commissioner Abdiasch Midesa said at the meeting that all those who returned home from outside the county in the last two weeks should register to the provincial administration for monitoring and possible quarantine.

The counties in the North Rift have united to enforce tough prevention measures. Governors have recalled all health officials from leave and

suspended public gatherings and vigils, on hand-to-handing and prevention of the disease.

Mandago, who chairs the North Rift economic bloc (Norob), said they had suspended all public meetings, including those in hotels, clubs

and nightclubs are also closed.

Health executives had also called for musicians with other stakeholders including churches, schools and other institutions to discuss how best to enforce control measures announced by the government.

Passenger who flew with Covid-19 case self-isolates

ELIUD WATHAKA A passenger who flew in the same plane with the woman diagnosed with Kenya's first case of Covid-19 is self-quarantined at a house in Cottage Hospital in Nanyuki town.

While briefing media on the state of coronavirus surveillance, preparedness and response,

Lakoba Health executive Dr Lewis Kamaria said the person will be quarantined until Thursday.

"We were informed on Friday of contact with the first index case who had visited Cottage Hospital. The contact has not shown any symptoms of Covid-19," Kamaria said at Nanyuki Teaching and Referral hospital.

He said the person is stable and assured of support from the hospital, the county and others.

Kamaria said the passenger had flown to visit a terminally ill relative admitted at the medical facility.

He ordered measures the county has put in place to caution residents against contracting and spreading the disease.

They include setting up quarantine centres with a total capacity of 53 beds in 10 health facilities.
