#### **Honorable Members,**

As you are aware, this House approved the motion on realignment of County Assembly Committees on 7<sup>th</sup> October, 2020. However a Court Order was issued on 14<sup>th</sup> October, 2020 (Kitui HEC petition no. EO2 of 2020 Josephine Kavivi Mutie and others vs County Assembly of Kitui), which directed that there be a stay of implementation of the resolution of the house of 7<sup>th</sup> October, 2020 until the hearing of the petition is finalized.

The same court during her ruling dated 13<sup>th</sup> November, 2020 lifted the stay orders on implementation of the report of the Selection Committee and directed that the resolution of the house on 7<sup>th</sup> October, 2020 be upheld.
