1.0 PREFACE

Mr. Speaker Sir,

The County Integrated Development Planning process is an exercise that envisions the position of a county in the future, based on the analysis of the present and past experiences. It is a tool for projecting the desired future of the county through prudent prioritization of the needs of the people of Kitui using the scarce county resources available.

The theme for the second Kitui County Integrated Development Plan (CIDP) for the year 2018-2022 is 'Transforming Kitui for Inclusive and Sustainable Development'. The CIDP outlines the policies, programs and projects that will be accorded priority during the next five years. It builds on the desired achievements of devolution since the promulgation of the Constitution of Kenya and also seeks to address the development needs of the people of Kitui County.

The document is expected to spur sustainable economic growth potential as well as address development challenges facing the county in addition to forming the basis for county budgeting.

Mr. Speaker Sir,

Article 220(2) of the Constitution states that 'National Legislation shall prescribe the structure of the development plans and budgets of counties'.

Further, Section 104 of the County Government Act provides that;

- (1) A County Government shall plan for the County and no public funds shall be appropriated outside a planning framework developed by the County Executive Committee and approved by the County Assembly.
- (2) The county planning framework shall integrate economic, physical,

social, environmental and spatial planning.

- (3) The County Government shall designate county departments, cities and urban areas, sub-counties and Wards as planning authorities of the county.
- (4) To promote public participation, non-state actors shall be incorporated in the planning processes by all authorities.
- (5) County plans shall be binding on all sub-county units for developmental activities within a County.

Mr. Speaker Sir,

Section 106 (2) further states that County plans shall be based on the functions of the county governments as specified in the Fourth Schedule to the Constitution and on relevant national policies.

Section 107 (1) (a) lists the County Integrated Development Plan as one of the frameworks to be formulated.

1.1 METHODOLOGY

Mr. Speaker Sir,

In considering the second Kitui County CIDP 2018-2022 for approval, the Committee considered a number of factors and parameters that were categorized as both quantitative and qualitative. A number of review objectives were set to guide in analyzing the plan particularly on the Constitutional and legal obligations of County Planning as best described under Article 220 of the Constitution, Section 106 and 108 of the County Government Act and Section 126 of the Public Finance Management Act. The Committee in preparing the report for approval of the CIDP 2018 - 2022, also ensured a wide stakeholders involvement.

1.2 PUBLIC PARTICIPATION

Mr. Speaker Sir,

Public participation forums were organised and conducted in five sub counties of the county in compliance with Article 196 of the Constitution of Kenya. These Public hearings and collection of views were held on 28th and 29th May 2018. Notification (by the Assembly) of the stakeholders was done by placing an advert in one of the main print media in addition to several announcements in the local radio stations. This approach ensured the views and comments of members of the public and other stakeholders were catered for, prior to consideration for approval of the County Integrated Development Plan.

1.3 COMMITTEE'S MANDATE

Mr. Speaker Sir,

The committee's mandate, functions and roles are as stipulated in the County Assembly Standing Orders No. 190 (4) and (5) and as contained in the second schedule of the same that outlines the subject areas for the sectoral committees.

The County Assembly Standing Order No. 190 (5) (b) states that; 'Each Sectoral Committee shall study the programme and policy objectives of

departments and the effectiveness of the implementation'

2.0 INTRODUCTION

Mr. Speaker Sir,

Through the office of the Governor, the County Executive Committee member in charge of the County Treasury, submitted the second CIDP 2018-2022 to the County Assembly on Thursday 17th May 2018. The document was tabled in the House on Thursday 17th May, 2018 and thereafter committed to the Finance & Planning Committee for consideration.

The Finance and Planning committee facilitated public participation of the CIDP on 28th and 29th May, 2018 in five centres namely;

- i. Mwingi resource centre Mwingi Central and Mwingi West Sub Counties;
- ii. Kyuso market Shed Mwingi North Sub County;
- iii. Mutomo Chief's Camp Kitui South Sub County;
- iv. Kitui Multipurpose Hall Kitui Central, Kitui West and Kitui Rural Sub Counties:
- v. Zombe AIC Kitui East Sub County.

Thereafter, all the sectoral committees retreated to Sai Rock Hotel, Mombasa from 19th-22nd July 2018 in order to examine and interrogate the Sectoral proposed programs and projects and subsequently present a report on the same to the Finance and Planning Committee. Upon receiving the sector recommendations, the Finance and Planning Committee reviewed the CIDP 2018- 2022, the public participation reports together with the sectoral reports and compiled this report.

2.1 LINKAGES OF THE CIDP WITH OTHER PLANS

2.1.1 CIDP Linkages with the County Government Act, 2012 Mr. Speaker Sir,

The County Government Act provides that County governments should prepare 5-year integrated county development plans and the annual county budgets for their implementation. Under Section 102 of the Act, county planning provides a platform for a unified sector-wide planning, budgeting, financing programmes, implementation, and performance review. The Act mandates the county planning unit for coordination of the integrated development planning. In addition, county planning shall serve as a basis for engagement between county government and the citizenry, other stakeholders and interest groups. It also states that the county planning framework shall integrate economic, physical, social, environmental and spatial planning.

2.1.2 CIDP Linkages with the Public Finance Management Act (PFMA)

Mr. Speaker Sir,

The PFM Act provides for effective and efficient management of public resources. Section 125 of the Act requires the budget process for county governments in any financial year to consist of integrated development planning process that includes long term and medium term planning as well as financial and economic priorities for the county over the medium term. Section 126 of the Act further obligates each county government to prepare an integrated development plan that includes strategic priorities for the medium term that reflect the county government's priorities and plans, a

description of how the county government is responding to changes in the financial and economic environment and the programmes to be delivered.

2.1.3 CIDP Linkages with the Urban Areas and Cities Act

Mr. Speaker Sir,

Urban Areas and Cities Act is categorical on the need for 5 year integrated development planning and the need to align annual budgeting to the plan. These plans are separate from those of the county. In section 36(2) of the Act, it states that "an integrated urban or city development plan shall bind, guide, and inform all planning for development and decision-making and ensure comprehensive inclusion of functions."

2.1.4 CIDP Linkages with the Constitution of Kenya

Mr. Speaker Sir,

The legal basis of the CIDP is enshrined in the Constitution under Article 220 (2) of the Constitution which states that National legislation shall prescribe—

- (a) the structure of the development plans and budgets of counties;
- (b) when the plans and budgets of the counties shall be tabled in the county assemblies: and
- (c) the form and manner of consultation between the national government and county governments in the process of preparing plans and budgets.

2.1.5 CIDP linkages with the Kenya vision 2030.

The Kenya Vision 2030 is the long-term development blueprint for the country that outlines the overall policy and strategic development agenda for

political, economic, and social transformation and development of Kenya including key flagship projects.

The three pillars are anchored on macroeconomic stability; equity and wealth creation; governance reforms; infrastructure development; energy; science; technology and innovation (STI); land reforms; public service reforms; human resource development; and security.

The Kitui County Integrated Development Plan 2018-2022 has mainstreamed the development agenda outlined in the Governor's Manifesto and accords priority to programmes and projects that support the goals of the Medium-Term Plan and Kenya Vision 2030. The Governor's Manifesto has five pillars for the social-economic and political transformation of Kitui County. These are food security and water, Universal Health Coverage, education and training; Wornen, Youth & People with Disabilities (PWDs) Empowerment; and Wealth Creation which are geared towards achieving these national goals.

2.1.6 CIDP Linkages with the sustainable development goals.

The Kitui County CIDP 2018-2022 has outlined programmes and projects that will be implemented to facilitate attainment of vision 2030 on Sustainable development goals. These include food security, Provision of health care, basic education, women, and youth empowerment as well as wealth creation. Further, the county will sensitize its residents on the relevant SDGs and prepare quarterly reports on the Status of implementation.

CIDP linkages with the governor's manifesto

Mr. Speaker Sir,

The Kitui County Integrated Development Plan (CIDP) for the year 2018-2022 is based on the development agenda outlined in the five pillars of Her Excellency the Governor's manifesto. These five pillars are outlined below;

Pillar 1: Food and Water

The CIDP focuses on establishing policies, programs and projects to enhance food security through support to agriculture, increase in irrigation and value addition. The proposed programs seek to enhance agricultural productivity through mechanization and crop production. The CIDP has also prioritized the provision of access to clean and sufficient water for domestic and commercial use through the provision of water harvesting programs (both surface run off, rain water and underground sources).

Pillar 2: Healthcare

The CIDP contains a number of programs aimed at providing and improving healthcare in the county. The County Government through the County Ministry of Health and Sanitation proposes to renovate and operationalize the non -operational Health Facilities, recruit additional healthcare workers, enhance service delivery through integrated data collection, provision of universal health care programs, strengthening of governance structures of hospital management boards and committees and equip health facilities and eventually upgrade Kitui and Mwingi General Hospital to level 5 referral hospitals.

Pillar 3: Women Empowerment

The county government is focused on empowering the women of Kitui County politically, socially and economically. The CIDP proposes a number of programs to capacity build women in order to empower them. The women are encouraged to form co-operatives societies which they will use as an avenue to access credit facilities and the procurement opportunities reserved for women.

Pillar 4: Youth and Education;

The CIDP contains programs aimed at scaling up the access to quality basic education through the provision of infrastructural development, staffing, and pro poor interventions in order to ensure improved standards of education. The county government intends to train youths on entrepreneurship skills, garment making and technical skills such as electrical, mechanical e.t.c. The County through the CIDP, plans to establish programs to support the youth e.g car wash businesses, offer them attachment and apprenticeship opportunities in addition to providing them with access to credit facilities to support their businesses. It further proposes a number of programs to support vocational training and ICT centres (VTC's).

Pillar 5: Wealth Creation;

The CIDP has also prioritized wealth creation through a Value Chain Approach that will seek to create an enabling environment for agriculture-based value addition chains. In particular, the Ndengu value Chain; Livestock and Poultry Value Chain, the Textile/Garment value Chain, Mango and other fruits Value Chain, Honey value chain, Ballast crushing, milk

processing, soap and detergent making, furniture making, charcoal and sand harvesting; and pottery and ceramics value chains. This approach will ensure that employment opportunities are generated.

3.0 GENERAL OBSERVATIONS AND RECOMMENDATIONS

The committee made the following general observations;

- a) The CIDP document contained a lot of misleading and inaccurate information, omissions, serious gaps and it contained information that was not relevant. The format used did not give adequate information e.g some program locations were listed as countywide thereby making it difficult to know the exact locations of the projects. This depicts a deliberate mischief or incompetence of either the consultant or the technical team that compiled document.
- b) The committee noted with concern that most baselines are indicated as zero which is not a true reflection of the current situation on the ground. This clearly demonstrates that there is disconnect between the ministry and the grassroots thus inviting the element of succession gap.
- c) For the quality consideration of the CIDP, the committee requires sufficient time to interrogate the document, interview the key stakeholders and compile a detailed report. To achieve this, the committee had to work long hours to ensure production of a reliable report on the same. The committee however encountered various challenges such as long working hours, delayed receipt of information thereby leading to the extension of additional time.
- d) The committee recommends that in implementation of projects, the principle of equitable share of resources has to be considered.

- e) The committee noted that there is need to propose affirmative action on some areas in regard to development. These areas are marginalized through ethnicity, geographical factors, inter-boundary clashes etc. There is need to come up with an affirmative action policy.
- f) The committee observed that there was no clear distinction between the donor funded projects and the county government funded projects within the Municipality. This increase the chances of duplication of programs.
- g) The committee noted that some villages had not been captured under the CIDP especially those from Nuu Ward.
- h) The committee also noted that the CIDP only contains the on-going and stalled projects for two ministries i.e Agriculture, Water and Livestock Development and Health and Sanitation while the rest are missing.
- i) Under the Ministry of Health and Sanitation the report did not reflect the actual number of stalled projects on the ground. Also a number of stalled projects for most sub counties were missing.
- j) The sector committees need to make a follow up with their respective ministries on where the 2018/2019 projects will be located. The ministries need to submit quarterly reports.

4.0 COMMITTEE'S SPECIFIC RECOMMENDATIONS Mr. Speaker Sir,

Based on the observations noted by the Committee, the views and comments submitted by various stakeholders including sectoral considerations by County Assembly Committees, public participation forums, development partners etc, this Committee hereby recommends the following;

4.1 OFFICE OF THE GOVERNOR

Mr. Speaker Sir,

This department has the mandate to provide overall leadership in the development and governance of the County. Its vision is to have a prosperous County with vibrant rural and urban economies where people enjoy high quality of life. The office is committed to providing effective County services and an enabling environment for inclusive and sustainable socio-economic development and improved livelihoods for all.

Its sector goals will be geared towards addressing issues to do with overall policy and leadership direction to facilitate County prosperity and competitiveness.

The broad priorities of the office of the Governor include the promotion of socio-economic development, building County disaster resilience, enhancement of the county image, governance, effective public service delivery and performance. These broad priorities will seek to address the multiple constraints that hamper the transformation of Kitui County which inter alia include; low resource base, harsh climate conditions, infrastructure gaps, high levels of poverty, low access to social economic services such as education, health, water, sanitation and energy.

This Committee agrees that the Office of the governor is very significant in delivering the five pillar manifesto as well as realizing the overall medium and other long term goals enshrined in the vision 2030 and other plans.

To achieve this the Committee therefore recommends the following: -

a) There is need for an urgent review of the CLIDP and Pro- poor regulations so as to ensure equitability in the sharing of the funds and services. The concept of equitability is far much suited rather than equality since we are all cognizant of the fact that the wards vary in

sizes, level of development, population notwithstanding the fact that some have a bigger number of villages as compared to the others therefore it would not be fair to allocate them the same amount of funds.

- b) The committee emphasizes the need and urgency of enacting an Equalization Fund Act.
- c) There is also need for the establishment of a program under CLIDP on the acquisition of land. This is because the county proposes projects yet they don't budget for the acquisition of land.
- d) The committee also agrees with the committee on Labour and social welfare's proposal to remove the sub program on infrastructural support to learning institutions and provision of sanitary material from the pro poor program and instead establish an independent program under the Ministry of Education.
- e) The committee recommends that the program on the Equipping of village polytechnics be prioritized to save them from collapsing. To supplement this, there should be sensitization of the local residents in order for them to appreciate the need for vocational training. The committee further recommends the formulation of policies and guidelines on the same together with the employment of additional tutors in the vocational training centers.
- f) The committee is aware that the Senate issued ceilings for the construction of Governors and deputy governor's residences. The CIDP proposes an allocation of Ksh 190 million for the two which is quite high and beyond the set limit. The committee therefore recommends that the money should be reduced and aligned with the Senate's recommendation.

- g) The program on county staff housing is misspelled and thus it should be corrected to read county staff offices. The program is meant to put up one office block for the county staff at the headquarter level.
- h) The committee recommends enhancement of disaster management and response preparedness program as a priority and there is need to develop a policy and legislative framework for the same.
- i) The program on HIV/AIDS and pornography control should be moved from the office of the governor and transferred to the Ministry of Health and Sanitation.
- j) The Program on human resource performance does not include baseline indicators thereby making it hard to know the current situation. The committee therefore recommends that the county should develop performance management systems.
- k) In the program on control of alcohol, drugs and substance abuse, the committee recommends the establishment of at least three rehabilitation centres in Kitui, Mutomo and Mwingi.
- To guide the implementation of programs under the office of the governor, the committee recommends the development of proper policies and legal frameworks.
- m) The committee also recommends the establishment of a program on intergovernmental relations. This will help to establish, co-ordinate and enhance collaborative relations.

4.2 MINISTRY OF ADMINISTRATION AND COORDINATION OF COUNTY AFFAIRS

This Sector has two sub- sectors which include Co-ordination of Administrative duties and Co-ordination and Tracking the Progress of County Projects.

Its objective is to have empowered communities that embrace national values that are imbued with leadership, administrative and communication capacity to effectively participate in governance at the local level. The Sector is also committed to ensuring and coordinating the participation of communities in governance at the local level and assisting the communities in developing administrative capacities for the effective exercise of the functions, powers and participation in governance at the local level.

In achieving the above, the Sector has proposed a number of programmes and sub- programmes to be undertaken within the period of five years. The Committee reviewed them and made the following recommendations; -

- a) The Program on decentralization of county services has a baseline of zero on the number of decentralized offices constructed. The ministry needs to indicate the number of offices completed, stalled and ongoing.
- b) In the spirit of devolution the committee recommends the establishment of procurement offices at the sub county level. This will in turn help in decentralizing services and also reducing corruption cases.
- c) Decentralization is not complete unless we have the lowest unit which are village councils. The committee therefore recommends the immediate establishment.

- d) The committee noted that the program on civic education has a very low set target. The targets should be increased since civic education is key to enhancing citizen participation.
- e) The committee recommends that the targets under the Program on environmental oversight should be doubled in each year.

4.3 COUNTY TREASURY

Mr. Speaker Sir,

The County Treasury is the ministry responsible for institutionalizing sound economic planning and prudent financial administration management and control in the County. The Sector has six sub sectors namely Administration and support services, Finance and Accounting Services, Budgets and Economic Planning, Revenue, Internal audit and Supply chain management.

Therefore, for other sectors to deliver on their mandates, the Treasury has to create an enabling environment by ensuring effective economic planning including budget preparation and reporting, mobilizing resources for implementation of programmes as well as producing county statistics.

The Committee reviewed the Ministry's proposed programmes and sub programmes and subsequently made the following recommendations;

a) That public participation be devolved to the lowest units of administration, that is the villages. This will ensure that the views and needs of the Musangi's and Musyoka's of Kitui County are addressed in realizing a five pillars manifesto that the government is committed to deliver.

b) The committee notes that there is no link between this ministry and sector committees and therefore the committee strongly recommends improved relations and regular reporting.

4.4 MINISTRY OF HEALTH AND SANITATION

Mr. Speaker Sir,

This is the Ministry responsible for providing quality curative, preventive, promotive and rehabilitative services to the residents of Kitui County. The Ministry has two subsectors namely, health and sanitation whose vision is to have a County with healthy residents that embrace preventive health care and have access to affordable and equitable health care services.

Mr. Speaker Sir,

For the Sector to achieve her goals, she is committed to providing accessible, affordable, quality health care services to all through strengthening health systems, scaling up health interventions, partnership, and innovation as well empowering communities to foster sustainable social and economic growth.

The County government of Kitui, through the Ministry of Health and Sanitation plans to increase access to healthcare services through interventions such as introduction of health insurance cover and encouraging residents to obtain NHIF comprehensive cover, equipping and adequately staffing the existing health facilities.

Mr. Speaker Sir,

The Committee noted with appreciation the intention by the County Ministry on Health and Sanitation to take this County to another level in terms of the

quality of health care provided. To achieve this, the Committee recommends the following; -

- a) On sub programme Immunization and vaccines, the committee observes that while the key outcomes under this sub programme will be reduced preventable deaths among children with key performance indicators being coverage of fully immunized children under the age of one year with a baseline of 70%, the planned targets over the five years are erroneously tabulated in mere figures instead of percentages. The committee recommends the inclusion of percentages to the targeted figures.
- b) Pertaining Sub programme; Reproductive Health, Maternal, Neonatal, Child Adolescent Health, whose key outcomes will be improved equitable coverage and utilization of RMNCAH services with the key performance indicators being women with unmet needs of family planning whose baseline is at 55.1% targeting to increase to 58.0% over the five years is erroneously tabulated in figures leaving out the percentages. The committee recommends the submission of updated baseline survey reports.
- c) On Sub programme health promotion, whose key outcome will be improved social behavioral changes, with key indicators being the number of CHVs trained on control of non-communicable diseases whose baseline is not available and the ministry targeting to constantly train a total of 2100 CHVs over the five years, the committee observes that for an effective community level health care this number is too low and requires to be increased by five hundred CHVs to be trained every year to realize a total of 2600 CHVs. The numbers of the same should

- be equitably sourced from all Wards considering certain level of qualifications.
- d) Further, the Sub programme on clean water and sanitation whose key outcomes will be improved water and sanitation at the household level with the key performance indicators being the percentage of households accessing clean water, targeting to raise from a baseline of 30% to 65% by the end of the fifth year, the committee observes that the budgetary allocation of 30 million shillings is too low. To achieve this target, the committee recommends the budgetary allocation be increased to 100 million shillings.
- e) On the Sub programme non-communicable disease control and prevention, whose key outcome will be increased prevention of morbidity due to non-communicable diseases with the key performance indicators being the number of women of reproductive age being screened for cervical cancer. The baseline is not available but the Ministry is targeting to screen 1200-2500 women by the end of the fifth year, the Committee observes that this targeted number of women is too low if the burden of the non-communicable diseases will be reduced. On the same note the Committee perceived that the burden of cancer does not affect women gender alone thus, it recommends inclusion of male gender as well as all ages and the numbers be increased to 12,000 - 25,000 annually. Further, the Committee recommends that the machines and personnel for diagonizing these non-communicable diseases be decentralized and members of the public be sensitized on the same and their location so as to increase the numbers of Kitui County residents benefiting from these services by the end of the fifth year.

- f) The committee recommends the completion of the stalled projects and operationalization of the completed ones.
- g) The committee is satisfied with the realistic goals, strategies and programmes proposed by the ministry which will see the county health sector grow to admirable levels if implemented to the latter. However, the committee urges the County Ministry to fast track the issue of formulating proper policies to govern the implementation of these plans and programmes.

4.5 MINISTRY OF EDUCATION I.C.T AND YOUTH DEVELOPMENT

Mr. Speaker Sir,

This Ministry has three sub sectors namely Education, ICT and Youth Development. Its vision is to be a nationally competitive Ministry in empowerment of children and youth with relevant knowledge, skills and attitudes through Basic Education and training. The Ministry is committed to empowering the people of Kitui County with proper quality knowledge, skills, attitudes, technology, and innovation through Basic education, training and skills development in order to improve their social welfare and economic well-being.

Mr. Speaker sir,

In order to harmonize and align the Ministry's programs so as to achieve optimum sector's benefits in this and the subsequent years, the committee therefore made the following recommendations;

a) The committed noted with great concern that the CIDP 2018-2022 does not contain a program on the establishment of a school feeding programme. The committee feels that this program is vital for enhanced

access, retention, transition and the general well-being of the children in our schools most especially those from needy families. The Ministry of Education should take note and implement the national regulations on early childhood education standard guidelines as envisioned by a motion on the implementation of model early childhood development education (ECDE) passed by the Second Kitui County Assembly.

- b) The committee recommends that the 2000 ECDE teachers that the County Government proposes to employ as casual should instead be employed on a permanent and pensionable basis.
- c) The committee also recommends that the bills of quantities for the construction of ECDE classes should include provision of water harvesting and sanitary facilities.
- d) The committee also recommends that the number of classes constructed should be increased from 40 to 100 annually. They should however be distributed on a need basis but not on a ward basis.
- e) The sub-program on establishment of community based universities should be removed completely. This is because Universities are not a devolved function and so the committee cannot allocate funds for such a project.
- f) In the process of implementing the programs on youth development, the ministry should endeavor to conduct feasibility studies so that they can make informed decisions to ensure prudent use of public funds.
- g) Under the project name 'establishment of centres of excellence in the five vocational training centres', there is a proposal for the establishment of centres in Mulango and Syongila. The committee feels that we cannot establish centers in both mulango and Syongila since they are both under the municipality. There should be diversity and

- equitable distribution of these centres. The committee therefore recommends the removal of Syongila from the list and replace it with Mwingi town.
- h) The Ministry should provide and empower the people of Kitui County with appropriate knowledge, skills, technology and innovation, that are relevant in attaining the Education and Youth Empowerment agenda. Therefore, the Ministry should be in the forefront in developing appropriate policies, actionable guidelines, and proper resource mobilization in broader partnership with private and other development sectors.

4.6 MINISTRY OF TRADE, CO-OPERATIVES AND INVESTMENTS

Mr. Speaker Sir,

This is the Ministry charged with the responsibility of undertaking the functions of trade development, regulations trade licensing, fair trade practices, cooperatives societies and markets as per the schedule four of the Constitution of Kenya. The Ministry is envisioned to be a facilitator in catalyzing competitive growth of trade, investment and cooperatives whose commitment will be provide an enabling business environment through appropriate incentives and innovations to promote trade, industry and visible cooperatives for job and wealth creation.

To achieve these, the Ministry has proposed a number of sector goals and strategic objectives focusing on key areas like; -

- i. Support and promotion of value chains;
- ii. Establish an investment corporation to facilitate development and wealth creation;

- iii. Support and strengthen SACCOS;
- iv. Support branding of County products and services;
- v. Support capacity building and awareness through partnering with Financial Institutions and other stakeholder.

The Committee went through the proposed programmes and subprogrammes in the Ministry in the CIDP and made a number of recommendations which will guide the Ministry in realizing her set goals and objectives; -

- a) The committee recommends that there should be decentralization of flag ship projects under this ministry.
- b) Under the program 'cottage industry development', the committee proposes the purchase of two ballast crushers per ward where applicable.
- c) The committee recommends that the leather industry should be put up at Kisasi, Kwa Vonza and Nguni. The ministry should also purchase quarry cutting machines for Mutha ward.
- d) Under the sub program on sand stocking yard, the committee recommends that every ward that has potential of supplying sand must have its own sand stock yard. The main sand stock yard at Kanyonyoo will be going to purchase sand from the ward level sand yards. There should ward designated sand collection points which should be secured.
- e) The committee recommends that the CIDP should contain a program on the acquisition of land for market construction.
- f) The committee recommends the enactment of the revenue administration bill to regulate revenue collection.

- g) The committee recommends that there should be a policy in place for the establishment of the Kamba wine program. Also the committee felt that the name Kamba wine is misleading, they should change it to the establishment of a Kamba local brew.
- h) On the construction of slaughter houses and county abattoirs, the committee recommends that the ministry should put up one major abattoir at Kanyonyoo and a modern slaughter house in each ward headquarter that does not have one. The committee recommends that there should be a policy in place for the management of the abattoirs and slaughter houses.
- i) The committee noted that the committees previously managing markets had been dissolved. This committee therefore recommends that the ministry should come up with a plan for streamlining the management of markets.
- j) The committee recommends that the jua kali sheds should be constructed in Mwingi, Mutomo and kitui towns.
- k) The committee recommends that modern kiosks should be constructed at ward level.
- The committee also recommends that the policy/legislations on the regulation of the County Bank and County Empowerment Fund should be formulated before the programs are rolled out.

4.7 MINISTRY OF LANDS, INFRASTRUCTURE, HOUSING AND URBAN DEVELOPMENT

Mr. Speaker Sir,

This ministry is composed of three directorates, lands, infrastructure, housing and urban development. The ministry's vision is to be a national leader in provision of devolved services related to Lands, Infrastructure, Housing & Urban Development. The committee reviewed the ministry's proposed programs and projects as contained in the CIDP and made the following recommendations:

- a) Preparation of county spatial plans the ministry has set a target of implementing two plans in year two and three. The committee advocates for processing of one spatial plan for Kitui County.
- b) The committee recommends that the number of kilometers to be graded under the sub programme gravelling and grading of roads be increased to a minimum of 4000km (100 km per ward) in each year from year two. The committee also recommends an additional sub programme on the construction of gabions and heavy grading.
- c) The committee agrees with the sectoral committee on LIUD's recommendation that the number of drifts to be constructed in year 2018/19 be increased to 80. In addition, the committee also recommended that 120 drifts be constructed from year 2 to 5 which should be shared equitably between the 40 wards.
- d) The committee also recommends the increase of construction of concrete drainage slabs from 10 to 80 in the 5 years to be shared equitably among the 40 wards. An assessment report must be done prior to the implementation of this program.
- e) The committee also recommends the increase of the number of box culverts constructed from 15 to 120 per financial year to be shared

- equitably among the 40 wards. The committee also proposes the enhancement of this budget to support the increment.
- f) The committee also recommends an increase in the number of pipe culverts from 20 to 120 in each year to be shared equitably in the 40 wards.
- g) On the program of building 5000 units in Kitui and Mwingi towns, the recommends that ministry of Lands should avail information regarding the specific items that the county government is going to sponsor given that it is a public private partnership. A policy on the same should be formulated.
- h) The committee recommends that the County Government should consider factoring in land acquisition in the Bills of quantities when proposing projects to be implemented especially where they are going to be undertaken on private land.
- i) The committee recommends the inclusion of a sub programme on the connection of Kitui County with Embu, Tharaka Nithi and Meru Counties whose key outcome shall be enhanced inter county relations in areas of Trade and Agriculture productivity, with key performance indicators being the upgrading of Kamuwongo- Thua irira road and opening of irira entry barrier.

4.8 MINISTRY OF TOURISM, SPORTS AND CULTURE

Mr. Speaker Sir,

This Ministry is crucial for the marketing of Kitui County as a tourist destination which greatly improve the county's revenue in addition to creating employment for the people of Kitui.

The Ministry's vision is to be the leading County Ministry in fostering social integration and economic well-being through promotion of Kitui County as a tourist destination of choice. The ministry is committed to developing and marketing sustainable tourism, sports and socio-cultural products through sound policy formulation and implementation in order to achieve socio economic empowerment.

Mr. Speaker Sir,

Tourism and sports entrepreneurship has become an important tourism market niche from the nineties. This focus is due to the large numbers of sport conscious travelers who opt for choices offering sport participation and spectatorship. In effect, there has been a substantial increase in the number of sport tourism activities.

Therefore in order to assist the ministry in achieving its goals, the committee made the following recommendations;

- a) The committee felt that the targets indicated under the sub program 'tourism product development' were not clear as to what exactly they were based on and therefore require additional information on the same.
- b) The Ministry must stick to the priority projects in the planned documents i.e. the ADP and CIDP.
- c) The committee also requires updated information on the number of usable stadiums within the county.
- d) The committee recommends the inclusion of a sub program on the establishment of three (3) talent centres within the county.

- e) The committee also recommends the inclusion of a sub program on the establishment of one (1) major cultural centre.
- f) The committee recommends the establishment of conservancies, parks and animal orphanages.

4.9 MINISTRY OF AGRICULTURE, WATER AND IRRIGATION

Mr. Speaker Sir,

This Ministry has three sub-sectors namely Agriculture, Water and Livestock Development.

The Ministry's mission is to provide effective technical agricultural and water supply services and information to farmers, fisher folk, water consumers and other stakeholders in the County through participatory extension and other appropriate methods and water management approaches in order to enhance food and water security.

Mr. Speaker Sir,

This ministry has a challenge to deliver to this house a policy framework that will enable operationalization of all the value chain programmes under it so as to enable oversight and accountability in the programmes.

Mr. Speaker Sir, to this effect, the committee makes the following recommendations for this sector:

a) To ensure prudence in spending of public funds, this Committee recommends that before the implementation of any project in the CIDP, relevant policies/laws have to be put in place and adhered to as a

- roadmap and guiding principle. For instance, the public procurement Act, Ndengu policy, among others.
- b) The committee gives water a priority in this County with water harvesting taking preference over water searching. As a result, the committee re-emphasizes the need of constructing one mega dam in every one of the 40 Kitui wards in two phases i.e. (20 in the first financial year and 20 more in the second year).
- c) On sub program Borehole drilling and equipping, the committee is of the opinion that Kitui County needs more water harvesting than water searching and recommends a reduction in borehole drilling and instead focus efforts and resources on other forms of water harvesting and environmental improvement. In this regard, the Committee recommends drilling of 120 boreholes (at least 3 boreholes per ward) in the five year period. To address challenges with existing boreholes, the committee recommends rehabilitation through installation of green energy, electricity connection, and purchase of standby generators. The committee also recommends excavation of additional earth dams, water pans and sand dams (and other subsurface dams) to ensure sustainable water supply.
- d) The Committee recommends that all bills of quantities for constructing earth dams should have designs on watering points for livestock, harvesting points, sanctions on delivery provision (pumping systems) and sanitation facilities (toilets).
- e) To ensure sustainability of earth dams, the Committee recommends soil testing, sound designing and construction. This will ensure water is retained and not lost to infiltration, seepage and leakage.

- f) The Committee recommends desilting and scooping of all the existing earth dams across the County.
- g) On sub program "Ndengu Revolution," the Committee recommends the formulation of a Ndengu policy before proceeding with the program.
- h) To achieve maximum benefit and impact of implemented programs, the Committee recommends sensitization, capacity building through proper trainings, and establishment of farmers support programs.
- i) To enhance poultry production and increase income generated from this enterprise, the Committee recommends a regular poultry vaccination program to mitigate against diseases and loss.
- j) On the sub program titled sorghum production, utilization and marketing, the Committee recommends that the County government should come up with a strategy to deal with the intrusion of birds on the crops. Farmers incur losses as a result of their crops being attacked and destroyed by the birds menace. This will ensure that the beneficiaries benefit from the programme and in turn ensure prudence in the utilization of public funds.
- k) On the sub- programme titled Agricultural extension offices (Construction and furnishing Agricultural headquarters offices) the Committee is of the opinion that the construction of new offices is not a priority considering that there are many stalled office construction projects in the wards addressing the same. Therefore, the Committee recommends that the ministry should focus on the completion, renovation and equipping of the stalled projects. In addition, the Committee observes that the allocation to this project is too high and

- recommends that half of the allocation goes to desilting and scooping of the existing earth dams.
- On the sub- programme, Agricultural Mechanization services whose objective is to provide subsidized agricultural mechanization services to farmers, the Committee agrees that this is indeed a good programme. They however recommend that the County government should focus more on the lease and hire of machines and services rather than purchasing new ones as this will prove expensive in the long run in terms of maintenance costs and lack of capacity to manage them.
- m) The committee recommends that all programmes dealing with ATC related activities should be merged.
- n) The committee noted that the CIDP contains so many small irrigation projects benefitting quite a few people. The Committee strongly discourages the government from this practice and recommends that all these allocations be moved to desilting and scooping of the exiting earth dams.
- o) It is important to note that the Committee appreciates the progressive increase in allocation to the Ministry and observes that most of the projects are viable. The Committee however urges the County government to move fast and draw policies in order to operationalize the same. Food, Water Security, and Poverty Reduction remain the key priority areas in Kitui County. The committee feels that these critical issues have been well captured in the CIDP.

4.10 MINISTRY OF ENVIRONMENT, ENERGY AND MINERAL INVESTMENTS DEVELOPMENT

Mr. Speaker Sir,

The use and conservation of natural resources such as water, land, soil, plants and animals affects a multitude of industries from agriculture and mining to tourism and forestry.

Mr. Speaker Sir,

The Ministry intends to maximize the utilization of electricity, alternative and renewable sources of energy as well as gainful exploitation of minerals in a sustainably managed environment. This will be achieved through environmental management, access to varied affordable sources of energy and increased levels of sensitization on the utilization of minerals so as to improve the livelihood of the Kitui residents.

The Ministry is envisioned to be the leading County in the utilization of electricity, alternative/renewable sources of energy and gainful utilization of minerals in a sustainably managed and healthy environment. She is also committed to improving the livelihoods of Kitui people through the provision of varied and reliable sources of affordable energy and increased levels of minerals investments in a sustainably managed environment.

a) In order to achieve her vision and mission, the Sector has proposed a number of programmes and sub-programmes which are geared towards achieving the same. This Committee went through the proposals and made the following recommendations; -

- b) The committee appreciates the issue of waste disposal management. It therefore recommends the establishment of a program to manage waste disposal across all the towns.
- c) Instead of having programs on the establishment of environmental clubs, the committee recommends that the ministry should instead establish environmental programs that will include clubs and eco schools.
- d) The government needs to come up with regulations of promoting green energy usage. This should start at the concept level. The county assembly should also come up with regulations to encourage Developers to put up commercial houses/ buildings with water harvesting facilities and green energy alternatives.
- e) The committee recommends and encourages the collaboration between national agencies such as Kenya Water Towers and county governments in order to ensure a streamlined and harmonized forest management.
- f) The sub program on the establishment of commercial tree nurseries, poultry and goats rearing should be transferred to the Ministry of Agriculture, Water and Livestock Development since they are more capable of implementing it better.
- g) The committee noted with concern that the ministry has allocated ksh 100 million for the promotion and installation of clean cook stoves. The committee feels this amount is unrealistically too high as one cook stove cannot cost kshs. 100,000.
- h) The committee also recommends that the key performance indicator under the sub program on resettlement action plan in mineral rich zones should be changed to the number of people resettled.

- i) The Ministry intends to establish an awareness creation program on cleanliness in towns/ markets. The committee recommends that the ministry should target to have sensitization meetings in every ward per year. Further the Committee recommends that this approach should be well spelt out on how the ministry intends to undertake it.
- j) County Climate change and adaptation; under this program, the Ministry intends to create awareness on climate change adaptation and mitigation measures in Mumoni, Ngomeni, Nguni, Tseikuru and Nuu Wards. However, the Committee recommends that under this priority, the Ministry should increase the proposed budget and at least factor in a climate change awareness project in every Ward.
- k) Tree growing and forest conservation; under this program, the Ministry intends to promote community participation in growing trees in order to increase awareness in tree growing. The Committee recommends that under this program, the Ministry should initiate a tree seedling nursery project in every Ward.
- Conservation and protection of rock catchments; with this program, the
 ministry plans to enhance water sufficiency in rural areas. The
 Committee recommends the conservation of all the rock and water
 catchment areas and not just the few mentioned in the CIDP.
- m) Rehabilitation of Mumoni hills, Endau Hills and Nuu Springs e.t.c to improve water catchment areas. The Committee recommends that Ndilini Hills in kanziko Ward, Kitui South be included in the list.
- n) The committee recommends that the Ministry should come up with a Disaster Risk Reduction program in order to curb the rising cost of humanitarian assistance and economic loss, while also protecting longterm development investments.

- o) The Ministry proposes to support construction and promotion of modern kilns for sustainable and efficient production of high value charcoal briquettes. Therefore the Committee recommends that the ministry should show a clear relationship between the Kilns and Briquettes.
- p) Clean Energy; the ministry intends to enhance Electrification of off-grid polytechnics, health centres with solar PV systems/ Mini grids for multipurpose. The baseline is identification of designed powerlines leading to the institutions initiated. The committee recommends that the solar systems should be installed in the institutions rather than be distributed through lines. Further the committee recommends that the planned target be increased to 8 per year to allow 1 project per Sub County.
- q) The committee recommends that the Ministry should have a wellcoordinated program to install proper street lighting in the ward headquarters.
- r) The Committee also recommends that the Ministry should review the Memorandum of Understanding (M.O.U) with R.E.A and address issues such as faulty lines, maintenance, transformers and low voltage.
- s) The committee recommends planned target for installation of solar street lights be increased to 800 per year.
- t) The ministry intends to form and capacity build Community liaison Committees in mineral rich areas. The Ministry's idea behind this priority is to enhance community participation in governance in mineral rich areas. The Committee therefore notes that Kitui County is endowed with a number of minerals such as Limestone in Mutha Ward, Limestone in Kanziko Ward, Coal in Mui Ward, Limestone in Mumoni Ward, and

- other areas and the ministry should therefore form liaison committees in all these areas.
- u) The committee noted with concern that there is a sub program on distribution of pico solars kits and subsidized LPGS cylinders to needy households. The committee recommends that the program be completely removed from the CIDP since this is not a priority and also the fact that Kitui County does not manufacture gas cylinders.
- v) The committee recommends that the program on community sensitization on wood fuel production be removed since the same can be discussed in other sensitization meetings. Also the committee needs more information on the set targets under the sub program promotion of sustainable and efficient production of briquettes.
- w) The committee recommends that the key performance indicator on the sub program titled 'resettlement action plan in mineral rich zones should be changed to 'the number of people resettled'.
- x) The committee recommends that the sub program on the establishment of cottage industries e.g small quarries, ballast etc should be transferred to the ministry of Trade, Co-operatives and Investments for easy management.

4.11 COUNTY PUBLIC SERVICE BOARD.

Mr. Speaker Sir,

Kitui County Public Service Board is established under the County Governments Act 2012, Section 57 to be responsible for the management of human resources in the County. The Board is a body corporate with perpetual succession and seal capable of suing and being sued in its corporate name,

Mr. Speaker Sir,

The functions of the County Public Service Board as provided for in Section 59(1) of the County Government Act 2012, on behalf of the county Government, includes

- i. Establish and abolish offices of the County public service;
- Appoint persons to hold or act in offices of the county public service including in the boards of cities and urban areas within the county and to confirm appointments;
- iii. Exercise disciplinary control over, and remove persons holding or acting in those offices as provided for under this Part;
- iv. Prepare regular reports for submission to the County Assembly on the execution of the functions of the Board
- v. Promote the values and principles referred to in Articles 10 and 232 of the constitution of Kenya 2010 in the County Public Service
- vi. Evaluate and report to the County Assembly on the extent to which the values and principles referred to in Articles 10 and 232 are complied with in the County Public Service;
- vii. Facilitate the development of coherent, integrated human resource planning resource planning and budgeting for personnel emoluments in Counties;
- viii. Advise the County Government on human resource management and development;
- ix. Advise County Government on implementation and monitoring of the national performance management system in Counties; and make recommendations to the Salaries and Remunerations Commission, on behalf of the County Government, on the

remuneration, pensions and gratuities for County public service employees

Mr. Speaker Sir,

a) In this sector the Committee recommends the formulation, implementation and review of relevant policies. This additional programme should be included in the CIDP which will ensure that the Board formulates, implements and reviews relevant policies such as reward systems, selection and recruitments systems etc. so as to ensure effectiveness of the public service.

4.12 COUNTY ASSEMBLY

Mr. Speaker Sir,

The Kitui County Assembly is one of the forty-seven (47) county assemblies established in Kenya under Article 176 (1) of the Constitution of Kenya 2010. The membership as outlined under Article 177 of the Constitution is as follows; -

- i. Forty (40) elected members from various wards within the county.
- ii. Seventeen (17) nominated members, nominated by the political parties represented in the County Assembly.
- iii. The Speaker, who is an *ex officio* member elected in accordance with Article 178 of the constitution.

The County Assembly of Kitui has got two departments namely; -

 Office of the Clerk (referred to as General Administration, Planning and Support Services) which comprises of Administrative, Finance, Works, ICT, Communications and Legal departments. The main objective of

- this office is to ensure effective and efficient coordination of County Assembly services.
- ii. Office of the Speaker (referred to as Legislation, representation and oversight) which comprises of the Plenary, Select Committees and Sectoral Committees. The main mandate of the Assembly is exercised by this department through ensuring that necessary legislations and administrative procedures are developed and adhered to for the good of Kitui people.

Mr. Speaker Sir,

The committee made the following recommendations;

- a) The committee noted that the CIDP does not contain a program on the construction of 40 MCA ward offices. The committee resolved that this is a priority and should therefore be included in the CIDP. Also the committee recommends that the same should be provided at an estimated cost of kshs. 144 million.
- b) The committee also recommends an additional project for the purchase of 40 motorcycles for the ward office assistants at an estimated cost of kshs 6 million.
- c) The committee feels that the proposed amount of kshs 200 million for the construction of a recreational facility is too high and should therefore be reduced by 100million. The excess ksh 100 million should be added to the construction of an office block within the County Assembly.

4.13 KITUI MUNICIPALITY

Mr. Speaker Sir,

The creation of well planned, vibrant and efficient urban centres is anchored in the Urban Areas and Cities Act, The County Government Act as well as the Constitution of Kenya. These statutes formed the basis of the Kitui Municipal Charter which ushered in the Kitui Municipality. Kitui County Headquarters is situated within the municipality and it has a population of about 155,806 residents.

The Municipality is composed of five sub sectors namely;

- i. Finance and Economic Planning.
- ii. Trade, Commerce and Industrialization.
- iii. Physical Planning, Infrastructure, Transport and Development Control.
- iv. Administration and Corporate Services.
- v. Environment, Culture, Recreation and Community Development.

Mr. Speaker Sir,

a) Kitui municipality has a total proposed budget of ksh. 1,880,000,000. Upon careful examination of the CIDP proposed programs for Kitui Municipality, the committee was satisfied with the projects and programs proposed. In addition the committee recommends the inclusion of a program on the establishment of a dumping site for waste management within the Municipality.

4.13 MWINGI TOWN ADMINISTRATION

Mr. Speaker Sir,

Mwingi town is one of the two major towns in Kitui County. Mwingi town is regarded as the commercial centre for the northern part of the County, wand it is composed of the following five sub sectors namely;

- i. Trade, Commerce and Industrialization.
- ii. Physical Planning, Infrastructure, Transport and Development Control.
- iii. Administration and Corporate Services.
- iv. Environment, Culture, Recreation and Community Developments.

Mr. Speaker Sir,

a) Mwingi Town has a total proposed budget of Ksh. 515,000,000 which basically targets the sub programs as encompassed in the CIDP, in accordance with the strengths and effectiveness of the main program. Upon careful examination of the CIDP for Mwingi Town Administration, the committee was satisfied with the programs and projects proposed together with their corresponding budget and thus adopt them without amendment.

5.0 PUBLIC PARTICIPATION REPORTS

The committee reviewed the public participation reports for the five centres be annexed and subsequently be included in the mother document, that is the CIDP 2018-2022.

6.0 CONCLUSION

Mr. Speaker Sir,

The County's total revenue projection for the planned period 2018-2022 is Kshs.60 billion. The proposed expenditure over the same period is Ksh.

140,547,750,000 hence an actual resource gap of Kshs. 80 billion. An elaborate plan aimed at filling the mentioned gap in the plan will involve various options available to the County including: -

- Generating revenue from service provision, partnership with non-state actor, development grants and loans expanding the base through trade and tourism, encouraging private investments and establishing light industries.
- ii. Host business forums and investors conference to attract investment and financing into the County.
- iii. Explore new and innovative financing mechanisms to attract private sector investment through mutually agreed arrangements.
- iv. Pursue Private Public Partnerships aimed at delivering some of the key projects.
- v. Provide information including website posting on viable programs and projects to attract potential investors.
- vi. Preparation of funding proposals to potential financiers and donors for consideration to be either directly by the communities or by County Government.

On the management of the internally generated revenue the executive plans to institute strict supervision by Automating revenue collection and installation of CCTV cameras in all barriers to avoid revenue leakage which the Committee supports.

The Committee generally recommends that projects as attached in annex II (Annex on list of Ward specific projects) will be funded as listed in order of priority (First listed funding- last listed funding basis) and secondly we urge the Department of Finance particularly the revenue section, to embark on

serious and aggressive collection of local revenue by expanding revenue streams.

Preamble

Mr. Chairman Sir,

The new Constitution 2010 contains the Constitutional basis for Kenya's new devolved system of governance. Article 210 (a) partly states that "there shall be openness and accountability including public participation in financial matters. Further, Article 174(c) states that the objects of the devolution of the government is to give powers of the self-governance to the people and enhance the participation of the people in the exercise of the powers of the state and in making decisions affecting them.

Mr. Chairman Sir,

This meeting on the Public Participation on the Kitui County Integrated Development Plan 2018 - 2022 was held from 28th May to 29th May, 2018 at Mwingi North Sub- County headquarters in Kyuso market shade, beginning from 10.00 a.m. Musyoka Kitheka from Kyuso village opened the meeting with a word of prayer.

The Chair Hon. Jefason Ngui Kiruru welcomed members of assembly, staff of Assembly and members of the public and thanked for attending the public participation exercise for the Kitui County Integrated Development Plan 2018 - 2022. He reiterated the importance of the exercise and further urged members of the public to participate actively since it is their right as stipulated in the Constitution of Kenya Article 196 (1) (b) inter alia states: "A County Assembly shall facilitate public participation and involvement in the legislative and other business of the assembly and its committees." He further informed members of the public that the exercise was taking place in four other regions in the County namely: Mwingi, Mutomo, Zombe and Kitui town.

The Chair took members of the public through the CIDP by providing a summary of the proposed projects in Wards in the Mwingi- North area namely: Kyuso, Tseikuru, Mumoni, Ngomeni and Tharaka to enable them to fully comprehend the contents of the CIDP. He informed them that the meeting' sole purpose was to collect the public's views on the County Integrated Development Plan which incorporated proposed programmes and projects to be carried out in the next five (5) years.

Challenges

The Members of Assembly and those of the Public cited the following challenges:

- i. Lack of proper Communication at the grass root level- Members observed that the local leaders i.e. Ward and Village administrators, Chairmen of local markets were not aware of the public participation exercise and these are the same people who could be used to disseminate the information to the people.
- ii. Members noted that it was difficult for people from far wards like Tharaka and Tseikuru to attend in large numbers since they spend a lot to get to the venue. The public recommended that the exercise be taken to ward level so as to reach everyone.

Feedback from the members of the public.

Upon presentation of the estimates, members of the public gave the following views:

1. KYUSO WARD

A. MINISTRY OF AGRICULTURE, WATER AND IRRIGATION

Peter Nzuki - Kyuso Village

He stated that Twinyua borehole was already there contrary to the CIDP which stated of construction of the same. What residents needed was installation of solar energy.

Jackson Mutisya Musyimi - Kyuso village

He recommended that Kivila Rock Catchment dam's capacity should be increased since it serves lot of people in the area to ensure constant supply of water.

Stephen Wambua – Mivukoni Village

He recommended:

- i. That there is need of a borehole at Manzuwa area.
- ii. The Four Ten Bridge borehole was left incomplete. The installation of the tank and tower is pending.
- iii. There is need to desilt the dams in the area.
- iv. Sand dams at Kwa Mulonzya, Kinyuri and Katungulu areas.
- v. Rennovation of sumoni rock water catchment reservoir and construction of water catchment at Manzuva rock.

Mary Munanie Kamami - Mivukoni Village

She proposed that the rehabilitation of Kamula Earth Dam should be prompt as it was destroyed by the preceding heavy rains.

- Mr. Julius Musyoka from Kimangau Village in Kyuso ward recommended construction of a borehole and drift at Kavuluko.
- Ms. Agnes Syombua proposed the construction of a borehole at Kalimbui in Tseikuru ward.
- Mr. Muthui Mwasi recommended the drilling of a borehole at Kalaa and an earth dam at Katuuni
- She also proposed the purchase and issuance of a water tank at Kasyunoo and the construction of a cattle dip at Kyuso village.
- Mr. Muthui Mwasi recommended the construction of Sand dams at Kivila Seasonal River, Ngomola River, Utiisi River and Kaaya. He also recommended the construction of a borehole at Ikukumwa and an earth dam at Kathumula.

- Mr. Dominic Kitema recommended the construction of a cattle dip at Kimu village, Kyuso village, Nzaalani and Matooni.
- Ms. Christine Kimanthi recommended the construction of an earthdam at Kiloki between Kwa Mbithi and Kitheka Mukiti and the rehabilitation of earth dams at Katemwa, Kanzeru, Mbangwani and Katambauku.

B. MINISTRY OF HEALTH AND SANITATION

Francis Mwangangi – Kyuso Village

He proposed that the Hospital at Mutooni should be rehabilitated since it is not functional currently and residents have to seek medical services at Kyuso town.

Stephen Wambua – Mivukoni Village

He proposed that:

- There is need for additional staff and construction of their quarters at Mivukoni Health Centre.
- ii. Mataka dispensary should be fully equipped and upgraded to a health centre so as to serve many people.

C. MINISTRY OF ENVIRONMENT AND NATURAL RESOURCES Ezekiel Musyoka & Martha Kanguliu - Kyuso Village

They proposed that the proposed establishment of the Jiko Poa initiative should include empowerment. The groups involved should be financed to enable them acquire the necessary raw materials.

D. MINISTRY OF LANDS, INFRASTRUCTURE AND URBAN DEVELOPMENT

Benard ulandi Muindi – Kyuso Village

He proposed that there was need for urgent repair of access roads within the town as they are in a bad state following the heavy rains.

It was also proposed that a bridge be constructed along the following rivers;

- River Nziitu at Ciokere in Kaivirya village
- River Kamboya Wikithuki in Musavani Village
- River Karumu at Kaningo in Musavani Village

Stephen Wambua – Mivukoni Village

He proposed:

- i. Renovation of Mataka Mazuva road
- ii. Roads connecting: Ngomano primary-Kwa vere primary-kwa mwinzi musili-manzuva rock catchment to manzuva primary, Kandongu-kwa matiti-kwa kathungu- kwa musya to Sumoni with one drift, mivukoni town-kandongu-kavatani-manzolo to kwa musemba with several drifts, liani kwa maluki-usi wiu-kwa mwanzia-kwa kyusya, mataka town to mivukoni town (grading and culverts needed) and installation of culverts along mivukuni town-Mughuusi road.
- iii. Construction of Kamangoi drift
- iv. Levelling and renovation of Mivukoni Kamwengi Kiamangao road
- v. Drifts at Kinyuri, Kwa Kithendu, Kakoo, Usi wiu, Katungulu, kwa-Vere, Mwosa and Kamang'oi

- vi. Drift at Kaalange along Maseki Katse road in Kimangao village
- vii. Stage sheds at Iiani Kwa Maluki and Kwa Mwinzi Musili
- viii. Fencing of Mivukoni stadium, construction of its pavilions and toilets
- ix. Construction of a public toilet at Mivukoni market

E. BASIC EDUCATION, TRAINING AND SKILLS DEVELOPMENT

Under the Ministry of, he proposed that:

- i. Kamwengi ECDE classroom should be prioritised.
- ii. ECDE classrooms at: Kwa Vere, Mughuusi and Mataka primary schools and Completion of Kamwengi ECDE classroom that has stalled for long.

2. TSEIKURU WARD

A. MINISTRY OF LANDS, INFRASTRUCTURE AND URBAN DEVELOPMENT

Peter Matei Nguu - Mulangoni Village

He proposed that:

- i. Mulangoni Mungusi Kathiani Kawongo market access road should be improved and subsequent installation of culverts on the same.
- ii. Electricity poles that have fallen along Kawongo Market due to the heavy rains should be moved and properly fixed.

MINISTRY OF TRADE, INDUSTRY AND DEVELOPMENT

- i. Propose the establishment of a mango processing plant at Kyuso since a lot of fruits go to waste during the Mango season.
- ii. Mr. Muthui Mwasi recommended the construction of a boda boda shed at Gai town.

- iii. Ms. Mwende Kimwele proposes installation of floodlights and construction of modern toilets at Kyuso market.
- iv. She also proposed the setting up of a women empowerment fund to help the widows of Kyuso ward.
- v. Mr. Dominic Kitema recommended the construction of a modern market shed at Kimu village and toilets at Matooni market. He also recommended the installation of floodlights at Matooni market, Kimu, Kimangau and Mbangwani Shopping centres.

CONCLUSION

Upon successful completion of the exercise, Members of the public urged their representatives (MCA's) to ensure that the projects/ programmes in the CIDP be implemented to the latter, a challenge that the Members of the County Assembly committed to undertake.

1.0 PREFACE

Article 196 of the Constitution requires a County Assembly to facilitate public participation and involvement in the legislative and other business of the Assembly and its Committees.

Section 125 of the Public Finance Management Act provides for County Integrated Plan which should involve both long term and medium term planning.

The Kitui County County Integrated Plan was forwarded to the County Assembly on 17th May, 2018 and following communication from the Chairperson on 17th May, 2018 thereafter committed to the stood committed to the Finance and Planning Committee as the relevant sectoral Committee to facilitate public participation on and scrutiny of the document.

In furtherance of the public participation principle, the Committee on Finance and Planning organized and successfully undertook a public participation exercise on the CIDP from 28th to 29th May, 2018.

The public was duly notified of the exercise through an advertisement in the Daily Nation on $21^{\rm st}$ May, 2018.

The public participation exercise took place at five (5) centres that is:

- i) Mwingi Resource Centre for Mwingi Central and West Sub Counties;
- ii) Kyuso Market Shed for Mwingi North Sub County;
- iii) Kitui Multipurpose Hall for Kitui Central, West and Rural Sub Counties;
- iv) Zombe AIC for Kitui East Sub County;
- v) Mutomo Chief's Camp for Kitui South Sub County.

This Report documents the views and recommendations of the citizens during the public participation exercise held in Kitui South at Mutomo Chief's Camp from 29th to 30th May, 2018.

2.0 PUBLIC OPINION AND VIEWS

Members of the public were taken through the CIDP 2018- 2022 and submitted their views, proposals and recommendations as below:

2.1. MUTOMO/ KIBWEA WARD- PG. 623

2.1.0 Kitoo Village

Ministry of Basic Education, ICT and Youth Development

It was recommended that:

- That the following additional project should be included in the CIDP:
 - Construction of an ECDE classroom at Ndiini.
- ii) The estimated cost of Kshs. 3 Million for construction of an ECDE classroom at Mung'aluni ECDE Centre is too high for one classroom and should be reviewed downwards.

Ministry of Trade, Co-operatives and Investment

It was recommended that high/ first priority be given to construction of Ndiini and Syunguni market sheds, both of which have been given 2^{nd} / medium priority, noting the urgent need for these sheds in the two centres.

<u>Ministry of Lands, Infrastructure, Housing and Urban</u> <u>Development</u>

Members of the public recommended that culverts and/ or drifts be included in the following roads as indicated:

- Heavy grading of a feeder road from Ndiini primary to Kanziluearthdam to kwa Koki Matheka- 4 culverts and 1 drift.
- ii) Heavy grading of a feeder road from vonde through muvuyuni primary to kanzilu earthdam- **1 culvert.**
- iii) Grading of Mung'aluni to Mitume Church Road 1 culvert.

They also recommended that the following projects should be included in the CIDP:

- i) Grading of Kitoo- Kithini- Kwa Mathingithi- Kwa Ngumbi-Ngiluni Road with 1 culvert, which should be given high/ first priority.
- ii) Grading of Kitoo Catholic Kaluluini road with 1 culvert, which should be given high/ $1^{\rm st}$ priority.
- iii) Grading of Ndiini Primary- Makongoni Road with 1 drift at Ngulungu, which should be given high/ 1st priority.

Water points should be added at Kitoo, Ndiini, Syunguni, and
Kakunio to ensure that more areas benefit from the project.

 This project has not been prioritized in the CIDP and should be given high/ first priority.
- iii) <u>Construction of a culvert at kwa Kanthi Mbuvi</u>
 This project name is incorrect and should be moved to the LIHUD Ministry as it is a road project.
- iv) <u>Muuma earth dam repair at peter mulatya.</u>
 This project should be renamed to Maumba earth dam at kwa Mbondo Kimanzi.

They further recommended that the following projects should be included in the CIDP:

- Desilting and repair of Kwa Musango earthdam.
- ii) Repair and fencing of Kwa Peter goat dip

In conclusion, the public participation exercise was successful and members of the public requested that their recommendations be taken into consideration during compiling of the final CIDP so as to ensure socio-economic development in Kitui South especially at the village level.

PREFACE

Mr. Chairman,

On behalf of the Assembly Team that visited Kitui Multipurpose Hall, led by members of the Committee on Finance and Planning, I wish to submit a summary of the public's recommendations on The proposed Kitui County Integrated Development Plan 2018-2022. The exercise was conducted on Monday and Tuesday, that is on 28th and 29th May, 2018 respectively, at the Kitui Multi-purpose Hall.

Mr. Chairman,

Article 174 (c) of the Constitution provides that one object of devolution is to give powers of self-governance to the people and enhance their participation in making decisions affecting them. Article 196 (b) of the Constitution of Kenya as read together with the County Governments Act, No 17 of 2012 Section 87 and Standing Order No. 120 (3), provide for the express participation of public in matters affecting them. It is for this reason that the County Assembly led by Members of the Finance and planning Committee took the proposed Kitui County Integrated Development Plan 2018-2022 to the people to give their views on the same. The exercise was conducted at Kitui Multi-purpose Hall on 28th to 29th May, 2018.

COMMITTEE'S OBJECTIVES

The objectives of the committee were to engage the residents of Kitui Central, Kitui West and Kitui Rural Sub-Counties to participate in the exercise by giving their views on the proposed Kitui C.I.D.P. 2018-2022 in exercise of their rights under the constitution.

CHALLENGES

The team together with the participants cited the following challenges:

- 1) Lack of access to copies of the proposed C.I.D.P documents.
- 2) Low literacy levels amongst the participants.

- 3) Poor attendance by those from far away wards.
- 4) Lack of transport facilitation-this made it difficult for the public to attend the public participation exercise consecutively.
- 5) The publicity on the venue, date and time as advertised through print media on this event which was not effective.
