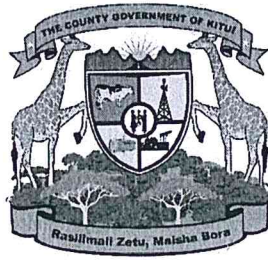

minority party not less than eleven and not more than nineteen members, who shall be nominated by County Assembly parties and approved by the County Assembly.

The Committee on selection shall nominate members to serve in committees, save for membership of the County Assembly Business Committee and committee on Appointments.

The Committee on selection shall be appointed within ten days on assembly of a new Assembly.

1.3 SUBJECT AREAS AS PER SECOND SCHEDULE OF THE STANDING ORDERS

Mr. Speaker Sir,

All matters relating to nomination of members to serve in committees, save for the membership of the County Assembly Business Committee and Committee on Appointments.

1.4 LIMITATION OF MANDATE (S.O 177)

Mr. Speaker Sir,

The deliberations of a select committee shall be confined to the mandate of the committee and any extension or limitation of that mandate as may be directed by the County Assembly and, in the case of select committee on a Bill, to the Bill committed to it and relevant amendments.

In the exercise of its functions, a select committee may not consider any matter that is not contemplated within the mandate of the County Assembly under the Constitution.



2.0 INTRODUCTION

Mr. Speaker Sir,

On 2nd September 2021 during the Committee on Selection online meeting, the Acting Chairperson, Hon. 

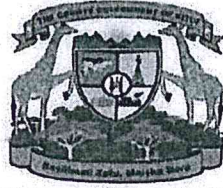
