1.0 EXECUTIVE SUMMARY

Hon. Speaker,

The County Assembly Standing Orders envisions the existence of a Committee to be known as Selection as provided for Standing Order No; 152(2) That shall nominate members to serve in Committees, save for the membership of the County Assembly Business Committee and Committee on Appointments.

In executing its role, the committee is guided by the provisions of the County Government Act, 2012 Section 14 (4) which provides that, the county assembly shall in establishing committees under this section ensure that each member of the County Assembly is appointed to at least one committee.

Further the committee was equally guided by the requirement in our County Assembly standing orders 153(2) which provides that; The Committee on Selection shall give consideration to the need for gender balance and shall, so far as may be practicable, ensure that no more than two-thirds of members of a committee of the County Assembly, including a committee established through a resolution of the County Assembly, shall be of the same gender.

Hon. Speaker,

As demonstrated in this report the committee made efforts to ensure that the interests of each member to belong to a committee and effectively participate in legislative activities is well addressed.

This Mr. Speaker is also taking into consideration the fact each the Assembly leadership based on Assembly parties met and agreed on formula that is 3 | Page

attached to this report (Selection 2) which guides how membership in committees is distributed giving precedence to the provisions stated above.

Hon. Speaker,

Just to highlight, on sectoral committee membership Wiper Party being the majority has (6) six, National Alliance Rainbow Coalition (NARC) (2) two, United Democratic Alliance (UDA) (1) one, Jubilee Party (1) one, Independent and Small Parties (1) one member in each committee.

Hon. Speaker,

It is also important to note the proposed formula as agreed had been used before by this Assembly during the composition of the Selection Committee, House Business, Public investments and Accounts and the Budget and Appropriations committees.

3.0 LEGAL FRAMEWORK

3.1 The Constitution and County Governments Act

Hon. Speaker,

Article 124 of the Constitution provides for creation of committees in the National Parliament and whose management should be provided for in the Parliaments' Standing Orders. Article 124 (1) of the Constitution provides that, each House of Parliament may establish committees, and shall make Standing Orders for the orderly conduct of its proceedings, including the proceedings of its committees.

Section 14 of the County Governments Act provides for procedure and committees of the county assembly. Section 14 (1) provides that, a county assembly- (a) may make standing orders consistent with the Constitution and this Act regulating the procedure of the county assembly including, in particular, orders for the proper conduct of proceedings; and (b) subject to standing orders made under paragraph (a), may establish committees in such manner and for such general or special purposes as it considers fit, and regulate the procedure of any committee so established.

Further, section 14 (4) provides that, the county assembly shall in establishing committees under this section ensure that each member of the county assembly is appointed to at least one committee.

4.0 COMMITTEE MANDATE

Hon. Speaker,

The committee's mandate, functions and limitations are stipulated in Standing Orders No's.152, 153, 154, 155, 156 and 157, that the Committee on Selection shall:

- Nominate members to Select and to Sectoral Committees save for the membership of the County Assembly House Business Committee and Committee on Appointments. This shall be done in consultation with the County Assembly parties;
- give consideration to the need for gender balance and shall so far as may be practicable, ensure that no more than two-thirds of Members of a Committee of the County Assembly, including a committee

established through a resolution of the County Assembly, shall be of the same gender;

- ensure that the membership of each committee reflects the relative majorities of the seats held by each of the County Assembly parties in the County Assembly;
- Except as the County Assembly may otherwise resolve, on the recommendation of the committee on Selection for reasons to be stated, no member shall be appointed to serve in more than three Sectoral committees;
- Within seven days upon nomination of members to serve in any committee of the County Assembly, present the list to the County Assembly for approval.

5.0 THE GENERAL COMMITTEE MANDATE AS PROVIDED FOR IN THE STANDING ORDERS.

Hon. Speaker,

Pursuant to Standing Orders Nos; 152, 153, 154, 155, 156 and 157, the strategic objective of the committee on selection is to enhance efficient selection of members to their various Committees in consultation with other County Assembly parties and in accordance to the practicable party-proportion within the County Assembly of Kitui.

7.0 INTRODUCTION.

Hon. Speaker,

This being a new Assembly (Third Assembly) constitution of Committees is of paramount importance as is the practice in all common wealth legislatures as it is a means of establishing institutional leadership and and providing services to the people as provided for in the Constitution.

The value and benefit accruing from the use of Committees, lie in the fact that they perform functions which, the House is not fitted to perform in plenary, such as: -

- (i) sitting as frequently as is desirable, including, sitting away from the precincts of the Assembly for longer hours;
- (ii) summoning persons to present oral evidence and written memoranda or documents:
- (iii) availing an environment that can facilitate presentation of details, sifting through evidence and formulating reasoned conclusions, consistent with the both the statute and procedure;
- (iv) carrying out inspection tours, inquiry on matters out of which reports with recommendations are submitted to the House; and,
- (v) forming sub-Committees for the effective and efficient discharge of varied issues within the mandate of the Committees

These functions are more efficiently carried out by small group of legislators.

Honorable Speaker,

Among the several advantages of Committees, include, the possibility of several of them operating at the same time, thus enabling many matters to be dealt with concurrently and expeditiously. Overall, by concentrating on specific matters or subjects, Committees also offer the benefits of specialization to both Members and staff. The conspicuous advantage that of Committees in common wealth legislative houses is the ability they provide for the Legislature to delve into and deal with virtually all sectors and units of departments within the Executive, by having these assigned to Committees other than dealing with them at Plenary.

8.0 COMMITTEE FORMULAE IN NOMINATION

In undertaking this exercise, the selection committee members unanimously agreed to be guided by the resolution of the party leadership meeting held on 12th October, 2022 (Annexed as Selection 2) so as to cater for the need to have at least each member belong to a committee.

The agreed upon distribution proportions of committee membership is as shown below;

Hon. Speaker,

The above distribution as earlier stated was used constituting the four select County Assembly committees already approved by this Assembly namely; County Assembly Business Committee, Selection Committee on 19th October, 2022 and Public Investments and Accounts committee and Budget and Appropriations Committees on 26th October, 2022.

It is on this premise that the committee retreated to Pride Inn- Azure Nairobi from 31st October, 2022 to 5th November, 2022 to constitute the committee membership with a view to execute this mandate.

9.0 COMMITTEE RESOLUTION ON CONSTITUTION OF COUNTY ASSEMBLY COMMITTEES.

Hon. Speaker,

Section 14(4) of the County Government Act, 2012, provides that the County Assembly shall in establishing committees under this section ensure that each member of the county assembly is appointed to at least one committee.

Further, the Standing Orders Nos; 152, 153, 154, 155, 156, and 157 clearly guides the committee on selection of its mandate, procedure of nomination of members of select committees, criteria for nomination, approval of nomination and composition of select committees.

Hon. Speaker,

Nomination of members to committees is executed by County Assembly parties and a member shall not be a member of a committee of the county Assembly, unless the nomination of such Member into the committee is approved by the County Assembly.

After reviewing all the Committees within its mandate and in exercise of the powers conferred to it, the committee on Selection resolved that the membership of various committees be as follows;

9.2 SECTORAL COMMITTEES

9.2.0 Appointment of Sectoral Committees (Standing Order 190)

- (1) There shall be select committees to be known as Sectoral Committees the members of which shall be nominated by the County Assembly Selection Committee in consultation with County Assembly parties at the commencement of every County Assembly.
 - (2) A member appointed to a Sectoral committee at the commencement of a County Assembly or at any other time during the term of a County Assembly shall, unless the County Assembly otherwise resolves, serve for the term of that County Assembly.
 - (3)Unless the County Assembly otherwise directs, the Sectoral Committees and the subject matter respectively assigned to them shall be as set out in the Second Schedule.
 - (4)The_mandate of Sectoral Committees in respect of the subject matter assigned under the Second Schedule of these Standing Orders shall only be exercised within the limits contemplated under Part 2 of the Fourth Schedule to the Constitution.

(5) The functions of a Sectoral Committee shall be to-

- (a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned departments;
- (b) study the programme and policy objectives of departments and the effectiveness of the implementation;
- (c) study and review all county legislation referred to it;
- (d) study, assess and analyze the relative success of the departments as measured by the results obtained as compared with their stated objectives;
- (e) investigate and inquire into all matters relating to the assigned departments as they may deem necessary, and as may be referred to them by the County Assembly;
- (f) to vet and report on all appointments where the Constitution or any law requires the County Assembly to approve, except those under Standing Order 185 (Committee on Appointments); and
- (g) make reports and recommendations to the County Assembly as often as possible, including recommendation of proposed legislation.

10.0 COMMITTEE CHALLENGES

The Committee on selection faces some challenges during the selection process including the following: -

- Assembly parties take longer time to agree on the nomination of Members which delays constitution of committees.
- There is a limited number of committees as provided for in the Standing orders to cater for all members of the Third Assembly.
- 3. The provision in law to cater for two third gender rule is proving to be a challenge to implement, due to the numbers of the lady honorable members in the 3rd Assembly and also putting into consideration the number of committees vis a vis the limitations in standing order 154(3).
- 4. The Committee has limited mandate to recommend changes to the list of nominations because it's the parliamentary parties who make the nominations.

11.0 COMMITTEE RECOMMENDATIONS

The committee came up with the following recommendations; -

- Consensus building in consultation is Key in executing our role as members of the County Assembly.
- ii. There is need to for the committee on procedure and rules to increase membership to the Committee on Public Accounts and investments from the current five (5) to make it nine (9) to cater for, more

- members and also enable the committee undertake its work effectively.
- iii. The County Assembly committee on procedure and rules should move with speed and divide the role of some committees with broad specter e.g. Agriculture, Water and Irrigation and the Lands, Infrastructure and Urban Development to two committees to ease its broad duties in view of the departments contained.
- iv. The County Assembly Service Board should ensure continuous capacity building for both members and staff so as to develop competencies and skills that can make quality legislations and at long term make the Assembly effective in achieving its constitutional mandate and vision.
