- v. Constitution of Assembly Committees, both Select and Sectoral pursuant to Section 14 of County Government Acts, 2012 and the County Assembly Standing Orders;
- vi. Consideration of the Supplementary Budget I for the financial year, 2022/2023 and its appropriation bill thereof;
- vii. Issuance of the Speaker's considered ruling on the Statement request on the vetting of the Kitui County Executive Committee Members nominees;
- viii. Motion on Kitui County Government pending bills;

- ix. The County Assembly Service Board was able to vet and approve the appointment of two members to the County Assembly Service Board in compliance with Section 46 (d) of the County Assembly Service Act, 2017;
- x. Consideration of H.E The Governor's Memorandum on the Kitui County Supplementary I Appropriation Bill, 2022 (C/A Bill No. 4, 2022);
- xi. Preparation of Committees' workplans and their subsequent draft budgets;
- xii. Pursuant to Section 8 of the County Governments Act, 2012 you were able to vet and approve nine (9) County Executive Committee Members;
- xiii. Motion of County importance on the proposed construction of High Grand Falls Dam in Tharaka and Tseikuru Wards in Kitui County; and
- xiv. Motion on resolution to petition the National Assembly on County Wards equitable development fund, among other achievements.

It is my pleasure to record that the above-mentioned milestones for the first session were realized within a timeframe of only three months and based on this we can only look forward to do even more and reach greater heights in this Second Session.
