# Mr. Speaker Sir,

His Excellency the Governor forwarded the list of the nominees to the positions of Chief Officers in various County Ministries for approval, to the Honourable Speaker on 19<sup>th</sup> December, 2022. This was pursuant to the provisions of Section 4 of the Public Appointments (County Assemblies) Approval Act that:

An appointment under the Constitution or any other law for which the approval of a County Assembly is required shall not be made unless the appointment is approved by the relevant County Assembly in accordance with this Act.

Committal to Sectoral Committees

# Mr. Speaker Sir,

Pursuant to the provisions of section 5(1) of the Public Appointments (County Assemblies) Approval Act, the Assembly received a message from the H.E. The Governor, In exercise of powers conferred by Section 45 (1) (b) of the County Governments Act, on the list of 26 nominees to the position of Chief Officers in the County Departments, 4 of whose approval fall under the oversight of the Committee.

The said names were thereafter committed to respective sectoral committees on 16<sup>th</sup> January, 2023 and publication done by the Clerk of Assembly on 23<sup>rd</sup> January, 2023 as required by Article 196 of the Constitution and Section 6(3) of the Public Appointments (County Assemblies) Approval Act that further provides that the Clerk shall notify the public in writing of the time and place for holding an approval hearing. At the same time, he invited written memoranda from the public that were to reach the County Assembly offices by the close of working hours on 27<sup>th</sup> January, 2023.

#### Committee Simulations

# Mr. Speaker Sir,

Prior to conducting public hearings, the Committee held numerous sittings between 26th to 28th January, 2023 at Summer Springs Hotel, Mwingi with a view to conducting simulations so as to equip members with the apt skills and technics hence enhancing high level of professionalism in public hearings.

The actual vetting by the committee took place on 30<sup>th</sup> January, 2023 within the County Assembly precincts.

The committee retreated to Cottages Resort Hotel, Mwingi to compile its report on the vetting exercise.

It is worth noting that the committee proceedings were taken verbatim by the Hansard office and even recorded live in the YouTube.

#### Committee observations and recommendations

#### Mr. Speaker Sir,

In execution of its function, the Committee reviewed oral responses to questions verbally asked by the committee members to all the four (4) nominees. They also replayed audio recordings to retrieve facts from the Hansard. There was massive review of documentary evidence in terms of copies of bio data, certified photocopies of both professional and academic certificates and other testimonials.

The committee having the approval hearing on the nominees regarding their suitability, observed that due process was followed on the recruitment process as provided for under Section 45 of the County Government Act (2012). # CHAPTER TWO 2.0 BACKGROUND.

2.1 Legal Framework

#### Mr. Speaker Sir,

Section 45 of the County Governments Act, 2012 provides that;

- (1) The governor shall—
  - (a) Nominate qualified and experienced county chief officers from among persons competitively sourced and recommended by the County Public Service Board; and
  - (b) With the approval of the county assembly, appoint county chief officers.
  - (2) The office of a county chief officer shall be an office in the county public service.
  - (3) A county chief officer shall be responsible to the respective county executive committee member for the administration of a county department as provided under section 46.
  - (4) The county chief officer shall be the authorized officer in respect of exercise of delegated power.
  - (5) The governor may re-assign a county chief officer.
  - (6) A county chief officer may resign from office by giving notice, in writing, to the governor.

# 2.2 Q qualifications for Appointment to the office of a Chief Officer

#### Mr. Speaker Sir,

The CPSB of Kitui set the following as basic requirements that one has to satisfy in order to be appointed to the office of a Chief Officer:

- Be a Kenyan Citizen.
- Be a holder of at least a first Degree from a University recognized in Kenya.
- A post-graduate qualification in the relevant field will be an added advantage but not mandatory.
- Have relevant knowledge and experience of more than five years in the relevant field.
- Satisfy the requirements of Chapter Six of the Constitution of Kenya 2010 on Leadership and integrity.
- Be conversant with the Constitution of Kenya and all the devolution related legislations.
- Possess an understanding and exhibit commitment to National Values and Principles of Governance and Public Service as outlined in Articles 10 and 232 of the Constitution of Kenya, 2010 respectively.
- Have the capacity to work under pressure to meet timelines.
- Have the ability to work in a multi-ethnic environment with sensitivity and respect for diversity

Be a strategic thinker and result oriented;

- Have excellent communication, organizational and interpersonal skills;
- Be computer literate.

# 2.3 Message from the HE Governor

#### Mr. Speaker Sir,

Pursuant to the provisions of section 5(1) of the Public Appointments (County Assemblies) Approval Act, the Assembly received a message from the H.E. The Governor, in exercise of powers conferred by Section 45 (1) (b) of the County Governments Acts, on Monday, 19<sup>th</sup> December, 2022 nominated the four, amongst other nominees for appointment to the position of Chief Officer, in various County Departments whose approval fall under the oversight of this Committee. This was also in line with Section 6(1) of the Act that provides that the appointing authority shall, upon nominating a person for an appointment to which the Act applies, notify the relevant County Assembly accordingly.

#### 2.4 Speaker's Committal

# Mr. Speaker Sir,

Upon receipt of the Message, the Speaker notified the Assembly of the Message from the Governor in a Communication dated 16<sup>th</sup> January, 2023 and forwarded the names and curriculum vitae of the nominees to the Committee on Agriculture, Water and Irrigation pursuant to the provisions of Standing Order 42(1) so as to conduct approval hearings as required under Section 45(1) (b) of the County Governments Act.

# 2.5 Notification to the public

# Mr. Speaker Sir,

Article 196 of the Constitution provides that County Assembly shall facilitate public participation and involve members of public in the legislative and other business of the Assembly and its Committees.

Further, Section 6(3) of the Public Appointments (County Assemblies) Approval Act provides that the Clerk should notify the public in writing of the time and place for holding an approval hearing. In view of that, the Clerk placed an advert on 23<sup>rd</sup> January, 2023 in the local dailies hence notifying the public of the time and place for holding the approval hearing of the nominees in accordance with the requirements of Article 196 of the Constitution and section 6(3) of the Act.

The Committee was to conduct the approval hearings on 30<sup>th</sup> January, 2023, from 9.00am in Tent one (1), within the Assembly Precincts.

#### 2.6 Notification to the Nominee

# Mr. Speaker Sir,

All nominees were notified that upon being shortlisted, they would be required to submit clearance certificates from various obligatory institutions with a view to ensuring that they met the requirements of Chapter Six of the Constitution of Kenya.

# 2.7 Clearance requirements

#### Mr. Speaker Sir,

The nominees were required to submit clearance certificates from various institutions with a view to ensuring that they met the requirements of Chapter Six of the Constitution of Kenya. The said certificates were further to be subjected to verification and authentication by relevant authorities.

#### These were:

- Kenya Revenue Authority (KRA)
- Credit Reference Bureau (CRB)
- Directorate of Criminal Investigation (D.C.I)
- Ethics & Anti-Corruption Commission (EACC)
- Higher Education Loans Board (HELB)

The County Assembly wrote to the below listed government agencies requesting them to issue reports on the nominees relating to the matters within the respective agencies' mandate: -

# a. Ethics & Anti – Corruption Commission (the Commission) Ethics and Integrity.

The Commission responded through a letter dated 26<sup>th</sup> January, 2023 Referenced EACC/10/5 VOL.XX11(15) stating that it had neither undertaken any investigations nor recommended prosecution against any of the nominees pursuant to its mandate.

# b. Kenya Revenue Authority

#### Tax obligation.

The Tax Compliance Certificates submitted by the nominees were confirmed by KRA by the letter dated 17<sup>th</sup> January 2023, Referenced CAK/ADM/15/7/ (100).

# c. Directorate of Criminal Investigations.

The DCI confirmed through a letter dated 23<sup>rd</sup> January,2023, Referenced DCI/CRO/SEC/6/7/2/A/VOL.XII/34 that the Certificates of Good Conduct held by each of the nominees were valid and authentic.

#### d. Directorate of Immigration.

#### Status of Citizenship.

The Directorate through a letter dated 25<sup>th</sup> January, 2023 confirmed that all the nominees were Kenyan citizens and none of them held dual citizenship.

# e. Higher Educations Loans Board.

All the nominees were cleared by HELB through a letter dated 24th January, 2023.

#### f. Office of the Official Receiver.

# Status of Bankruptcy.

The Official Receiver through a letter dated 17th January, 2023 confirmed that none of the nominees had been subject to any insolvency proceedings.

# g. Office of the Registrar of Political Parties.

# Political Party affiliations.

The Registrar of Political Parties through a letter dated 23rd January, 2023 confirmed that none of the nominees were officials of any registered political party.

#### h. Universities.

# Authentication of Nominees' academic certificates.

All the concerned Universities confirmed that the degree certificates held by all the nominees were authentic.

# i. Kenya National Examination Council.

#### Statement of Examination Results.

The Council confirmed that Certificates of Secondary School Education held by all the nominees were authentic .

# j. Credit Reference Bureau.

Metropol CRB Ltd and CreditInfo confirmed that the Credit Reference Certificates submitted by the nominees to the County Assembly were valid and authentic.

# 2.8 Committee proceedings

# Mr. Speaker Sir,

The committee allocated the nominees a maximum of one hour for vetting. In conducting the exercise, the committee was guided by among other documents; The Constitution, the Public Appointments (County Assembly's Approval) Act, No. 5 of 2017 and the County Assembly's Standing Orders.

None of the committee members had any conflict of interest with either of the nominees.

The committee considered the following criteria in vetting the nominees

- a) Work experience (as it relates to the position)
- b) Education /training (relevant to the position)
- c) Interest in and knowledge relating to specific position.
- d) Communication skills (written/oral)
- e) Presentation (promptness, neatness of resume/application, appearance)
- f) Decision making /problem solving skills.

# CHAPTER THREE 3.0 APPROVAL OF HEARINGS. Mr. Speaker Sir,

The committee noted that section 8 (a) of the Public Appointments (County Assembly Approval) Act, 2017 which outlines the procedure used to arrive at the nominee including the criteria for the shortlisting of the nominee was fully disclosed to the committee.

# 3.1 Submission of relevant documents from the nominee

The committee received the following documents from the nominees

- i. Curriculum vitae, personal credentials and academic certificates.
- ii. Online compliance certificate from Kenya Revenue Authority (KRA).
- iii. Personal declaration from the Ethics and anti-Corruption Commission (EACC).
- iv. Clearance certificate from the Higher Education Loans Board (HELB).
- v. Police clearance certificate from the Criminal Investigation Department (CID).
- vi. Clearance certificate from the credit reference bureau (CRB).

#### **CHAPTER FOUR**

# 4.0 COMMITTEE OBSERVATIONS AND FINDINGS.

#### Mr. Speaker sir,

The observations and findings guided the Committee to conclude its final recommendations which were unanimously agreed upon by the Members during the adoption of the report on the vetting exercise at Mwingi Cottages Resort from 1st to 5th February, 2023.

#### Mr. Speaker sir,

The findings were as follows: -

# 4.1 NATHAN KASAMBA VUNGO NOMINEE TO THE POSITION OF CHIEF OFFICER, DEPARTMENT OF WATER.

Nathan Kasamba Vungo, the nominee for the position of Chief Officer, County department of Water appeared before the Committee on 30<sup>th</sup> January 2023 at 9.00am and was vetted under oath.

The Committee noted the following:

# Date and place of birth.

The nominee is a male Kenyan citizen born in 1975 in 28th May 1991, Kitui County, Kitui central Sub County, Changwithya West ward.

# Academic and professional qualifications.

The nominee holds a Bachelor's Degree in Agribusiness Management from Egerton University where he achieved First class honours, and a Master's Degree in Strategic Management from the University of Nairobi. He is currently pursuing a Doctorate in Strategic Management at JKUAT. He is an associate member of auditors of Kenya and also a Member of Institute of certified public accountants of Kenya.

#### Work experience.

The nominee has over ten years work experience and worked as the Kitui Town Administrator between 2013-2017 where he was involved in financial management, project planning and management, monitoring and evaluation of projects within Kitui Municipality. He has also worked as the Senior Auditor and an Accountant in County Pension Fund (CPF), worked in Safaricom LTD as employee and currently working as Assistant Director of Education and a parttime lecturer at Kenyatta University.

#### Income and net worth.

He estimated his net worth to be Kenya Shillings Ten Million (Kshs10,000,000) Integrity.

The nominee submitted that he has never been charged in any court of law or adversely mentioned in any investigatory or parliamentary report of inquiry.

#### State or public officer.

The nominee submitted that he is a public officer currently working as Assistant Director of Education in Kitui County and will relinquish his position once approved.

# Original Documents.

During the approval hearing, the nominee submitted the following original document to the Committee for confirmation.

- i. Identification Card.
- ii. Degree certificate.
- iii. Other testimonials.
- iv. Clearance Certificates from: -DCI, EACC, HELB, CRB and KRA.

#### 4.1.1 SECTOR SPECIFIC QUESTIONS TO THE NOMINEE.

The Committee posed several sector specific questions to the nominee to which he responded as follows:

# On suitability to the position appointed.

The nominee cited that chief officer is the accounting officer of the Ministry, which is her core competence. Having been an accounting officer for Kitui Municipality.

He also cited that, he is a team leader, having attended the highest level of training by Kenya school of government called strategic management. He further cited that the position of chief officer needs someone who can implement projects; which is evident by the number of projects he implemented when he was the Town Administrator of Kitui Municipality. For example, he spearheaded the tarmacking of roads at Kunda-kindu all the way to Kitui School, roads around Majengo, transferred jua-kali traders from roadsides to jua-kali area, which demonstrate leader and capacity to manage projects. This gives him wide perspective in leading and managing the docket effectively.

The nominee further cited that, he is aware that the budget is not enough and therefore the position needs someone who can mobilize resources

On measures to address water scarcity in Kitui County.

The nominee cited that he will apply integrated approach in line with the governor's manifesto which emphasis on four crucial areas namely:

- 1. Construction of eight mega dams in the entire County, one in every Sub-County in order to harvest water.
- 2. Drilling and equipping of many boreholes as possible after doing geological survey.
- 3. Construction of forty medium- size dams, one in each Ward.

- 4. Construction of small dams in every village.
- 5. Water pipeline extension from Masinga and Kangu-Kangu.
- 6. Installation of digital water meters to address the issue of water leakage since a lot of water is lost through leakages.
- 7. Facilitate private citizens to drill boreholes and distribute water to their neighbours at a subsided price.

#### On the Governor's manifesto;

The nominee cited that the governor's manifesto in regard to her docket is to have water sufficient County.

The also cited that the governor's manifesto has sixteen points and water is the nerve centre of the manifesto; you cannot do agriculture without water. Therefore, his ministry will play a critical role in delivering on the manifesto. He further cited that the governor's manifesto is postulated on our County Vision and he participated in developing the Kitui Mission on Economic and Social transformation 2016/2017.

On measures to put in place in order to get energy to distribute water;

The nominee cited that the solution to energy is doing hybridization — integrate solar with a generator and maybe electricity to reduce cost. Therefore, he will emphasis on installation of solar in every borehole. He also cited that they have already proposed the use of solar energy in Masinga dam in order to cut the cost of pumping water which is the biggest challenge.

He further cited that most of the community-based schemes are unsustainable due to high-cost fuelling generators.

# On the Kitui water companies;

He stated that we have two water companies that is KITWASCO and KIMWASCO. KITWASCO has been facing mismanagement issues touching on

billing, irregular connections and integrity issues. He will conduct audit on the company operations to know the structural and human resource challenges affecting the company and come up with strategies or decisions for proper management of the companies to ensure efficiency and effectiveness in offering services including pipeline extensions and stop dependency on subsidies.

# 4.1.2 COMMITTEE OBSERVATIONS ON THE SUITABILITY OF THE NOMINEE.

**Drip irrigation-**the nominee highlighted that, it is the most efficient when it comes to reducing water use as it filters down through the soil, virtually eliminating wasteful water runoff hence supplying the amount of water required by the plant direct to its roots. The nominee also cited that the method is affordable.

**Sprinkler Irrigation**-The nominee also highlighted that this type of irrigation doesn't involve any loss of water as it is similar to natural rainfall, that is water is distributed through a system of pipes usually by pumping and then sprayed into the air through sprinklers so that it breaks up into small water drops which fall to the ground. The nominee also cited that the method is affordable.

The nominee submitted that the Governor's manifesto majorly addresses the issues on water, agriculture, health, trade, education and urban development. She also cited that the Governor's address emphasised on having well maintained, sufficient and sustainable irrigation schemes. 


