## 3.0 COMMITTEE MANDATE

## Mr. Speaker Sir,

The committee's mandate, functions and limitations are stipulated in Standing Orders No's.152, 153, 154, 155, 156 and 157, that the Committee on Selection shall:

- Nominate members to Select and to Sectoral Committees save for the membership of the County Assembly Business Committee and Committee on Appointments. This shall be done in consultation with the County Assembly parties;
- give consideration to the need for gender balance and shall so far as may be practicable, ensure that no more than two-thirds of Members of a Committee of the County Assembly, including a committee established through a resolution of the County Assembly, shall be of the same gender;
- ensure that the membership of each committee reflects the relative majorities of the seats held by each of the County Assembly parties in the County Assembly;
- Except as the County Assembly may otherwise resolve, on the recommendation of the committee on Selection for reasons to be stated, no member shall be appointed to serve in more than three Sectoral committees;

 Within seven days upon nomination of members to serve in any committee of the County Assembly, present the list to the County Assembly for approval.

#### 4.0 THE STRATEGIC OBJECTIVE OF THE COMMITTEE.

Pursuant to Standing Orders Nos; 152, 153, 154, 155, 156 and 157, the strategic objective of the Committee on Selection is to enhance efficient selection of members to various Committees in consultation with County Assembly parties and in accordance with party-proportions in the County Assembly of Kitui.

#### 6.0 INTRODUCTION.

## Mr. Speaker Sir,

The review of the committee membership was occasioned by the swearing in of a new member representing Kyome / Thaana Hon. Alphonse Mukwaiyu Musyimi on 16<sup>th</sup> January, 2023 and the concerns raised by Honorable members regarding disproportionate allocation of committees which disadvantaged members. Subsequently, the selection committee and the House leadership resolved to review the committee membership to cure the outcry.

#### Mr. Speaker Sir,

It is important to note that the reorganization of committee membership fully adhered to the agreed upon formula between the Assembly parties.

It is on this premises that the committee retreated to Mwingi Cottages Resort from 9<sup>th</sup> – 11<sup>th</sup> March, 2023 to review the membership and reorganize the committees taking into consideration inclusion of the new member.

## Mr. Speaker Sir,

The committee did not receive any proposed changes from the Minority party (NARC), United Democratic Alliance (UDA) and JUBILEE Party.

# 7.0 COMMITTEE RESOLUTIONS ON REORGANIZATION OF COUNTY ASSEMBLY COMMITTEES.

## Mr. Speaker Sir,

Section 14(4) of the County Government Act, 2012, provides that the County Assembly shall in establishing committees under this section ensure that each member of the County Assembly is appointed to at least one committee.

Further, the Standing Orders Nos; 152, 153, 154, 155, 156, and 157 clearly guides the committee on selection of its mandate, procedure of nomination of members of select committees, criteria for nomination, approval of nomination and composition of select committees.

## Mr. Speaker Sir,

Nomination of members to committees is executed by County Assembly parties and a member shall not be a member of a committee of the county Assembly, unless the nomination of such Member into the committee is approved by the County Assembly.

After reviewing all the Committees within its mandate and in exercise of the powers conferred to it, the committee on Selection resolved that the membership of various committees be reorganized as follows;
