In view of the above, the County Executive Committee Member for Finance, Economic Planning and Revenue Management submitted to the Assembly the budget estimates for the Financial Year 2023/2024 on 28<sup>th</sup> April, 2023 for approval in accordance with the law.

#### Honorable Members,

Pursuant to the provisions of Section 131 of the Public Finance Management Act, 2012 as read together with Standing Order No. 206, I hereby commit these annual budget estimates for the financial year 2023/2024 to the County Budget and Appropriations Committee for Consideration. The Committee is expected to subject the estimates to public participation pursuant to Article 196(b) of the Constitution as read together with Section 115 of the County Governments Act, 2012.

Further, the Committee shall take into account the recommendations of the Sectoral Committees, the views of the County Executive Committee Member for Finance, Economic Planning and Revenue Management, and incorporate the views of the public in making her final recommendations to the House for approval.
