- (2) In preparing a quarterly report for a county government entity, the accounting officer shall ensure that the report—
- (a) contains information on the financial and non-financial performance of the entity; and

(b) is in a form determined by the Accounting Standards Board. Subsection (4) requires the County Treasury to consolidate the quarterly reports and submit them to the County Assembly.
