I kindly urge the relevant Committees to expedite their efforts in conducting the necessary inquiries and investigations, aiming to provide the House with statement responses at the earliest opportunity. Delaying these responses could potentially render them ineffective, and there is a risk that certain matters could become time-sensitive and ineligible for consideration.

C. Bills

Honourable Members,

This is an area that requires heightened attention from our Assembly. I can distinctly remember issuing a call to action to all County Assembly Committees not long ago, urging them to draft a minimum of two (2) Bills during this Session. In the period preceding to this recess, the Assembly has only managed to approve the **Kitui County Appropriations Bill, 2023**. This has raised concerns for me, considering that we are left with only four months to the end of the session, which is contrary to the goal set earlier.

D. Oversight activities
