EXECUTIVE SUMMARY

The Committee on Trade, Industry, ICT and Cooperatives conducted an extensive inspection Exercise of Market sheds, Slaughterhouses, and Stock Sales yards across the county from August 7th to 11th, August, 2023.

The report begins with an introduction highlighting the honour and privilege by the Committee to present the findings and recommendations of the exercise to the House. It outlines the composition of the Committee and its mandate as well as acknowledges the support received during the execution of her mandate.

In the background section, the report highlights context for the inspection, emphasizing the role of County Assemblies in oversight functions and the importance of effective governance. It also summaries the objectives of oversight, setting the itinerary for the Committee's activities.

The bulk of the report is dedicated to detailing the specific findings from the inspection, including observations and recommendations for improvement. Each Market shed, Slaughterhouse, and Stock Sales Yards visited is thoroughly evaluated, highlighting both positive aspects and areas requiring attention. Specific recommendations are provided for in each location, addressing issues such as infrastructure, sanitation, water supply, and waste management among others

The report further highlights common challenges faced across multiple locations, such as water scarcity, inadequate infrastructure, and the need for stakeholder involvement.

Based on the findings and observations, the Committee presents a set of comprehensive recommendations aimed at addressing the identified issues. These recommendations cover a wide range of areas including infrastructure improvement, regulatory compliance, stakeholder engagement, automation of revenue collection, and waste management.

The report concludes by underscoring the importance of continued oversight to ensure proper utilization of public funds and effective service delivery to the citizens of Kitui County It emphasises the commitment and dedication of the Committee to uphold accountability and good governance by county government through effective and timely oversight.

2.0 BACKGROUND INFORMATION

Mr. Speaker Sir,

Chapter Eleven of the Constitution establishes devolved governments by creating 47 County Governments. A County Government consists of a County Assembly and the County Executive.

The roles of County Assemblies as provided for under Article 185 of the Constitution and Section 8 of the County Governments Act, 2012 are representation, legislation, oversight over the County Executive Committee, approving County development planning, approving of budget and expenditure of the County Government, and approving borrowing by the County Government.

County Assemblies make laws applying to the respective County as provided for under Article 185 of the Constitution.

The Fourth Schedule of the Constitution as read together with Standing Order No 190 mandate the Committee to investigate, inquire into and report all matters trade development and regulations, including markets, trade licences, fair trading practices, cooperatives and marketing structures.

The oversight function is one of the cornerstones of democracy. It is a means of holding the executive accountable for her actions and for ensuring implementation of policies/plans in accordance with the laws, and determine whether current laws and appropriations are achieving intended results as passed by the County Assembly. The robust monitoring of the executive by the Assembly is an indicator of good governance. Through both legislative and oversight roles the County Assembly ensures checks and balances over the Executive arm of the County Government and asserts her role as the defender of people's interests.

2.1. Objectives of oversight

Mr. Speaker Sir,

The following were the objectives of the aforementioned oversight exercise; -

- i. Ensure transparency and openness of executive activities.
- ii. Hold the executive to accountable.
- iii. Provide financial accountability.
- iv. Uphold the rule of law.

In realization of the above objectives the Committee embarked on the inspection exercise to get firsthand information regarding market sheds, slaughterhouses and the stock sales yards across the county as from 7th to 11th August, 2023.

2.2. METHODOLOGY

Hon. Speaker Sir, the Committee adopted following methodologies to compile the report: -

- i) The Committee held preparatory meeting to draw its work plan.
- ii) Oral Interviewing of County and National Administrators and the general public.
- iii) Documentary review as submitted by the County Ministries.
- iv) Site visits of projects

3.0 COMMITTEE FINDINGS

3.1. Zombe Slaughterhouse.

Mr. Speaker Sir,

The Committee visited the Slaughterhouse in Zombe town on 7th August 2023, and found that it is privately owned. The proprietor informed the Committee that: -

- i. In an ordinary day there are seven (7) goats slaughtered and during the market days they range from 17 to 20 goats,
- ii. There is an acute water shortage in the area, which is pumped from the nearby river. However, he informed the members that he owns a water boozer to supply water in the facility.
- iii. Service charge of Kshs. 70 and Kshs. 100 is charged for a goat and a cow respectively.

- iv. No office for handling day to day cash transactions and records keeping of the same.
- v. There is an ablution block with no hand washing water point.

Specific recommendations

The Committee recommends that the County Ministry of Trade, Industry, MSMEs and Cooperatives should put up, as a matter of urgency, a modern slaughterhouse in Zombe town to offer better services and step-up own source revenue.

3.2 Zombe Market Shed

Mr. Speaker Sir, the Committee accompanied by the Revenue officer and the Enforcement officers visited Zombe market shed on 7th August, 2023. The following were the findings and observations: -that

- i. There was a dilapidated National Government market shed constructed in the early 90's and remained non-operational for more than 20 years.
- ii. The committee observed that the structure looked abandoned, habitant for all non-productive businesses.
- iii. In the same site, the County Government had put up a market shed constructed in the financial year 2015/2016 which had stalled.
- iv. The market structure floor had developed cracks, with exposed concrete BRC wire mesh as well as vandalized metal stands.
- v. The market solar lights had also been vandalized, thus causing insecurity in the area.

Specific recommendations

The Committee recommends that the County Ministry of Trade, Industry, MSMEs, Innovations and cooperatives should;

- i. Demolish the abandoned National Government market to create space for market expansion.
- ii. Repair of the County Government market shed.

iii. Ensure maintenance of the market solar light.

3.3 Mutha Market shed.

Mr. Speaker Sir,

The Committee visited Mutha Market Shed on 7th August, 2023 and made the following observations: -

- i. The market shed was busy and operational.
- ii. The Market shed floor had developed cracks with an exposed BRC wire mesh which were posing health hazard.
- iii. There were two water storage tanks of 5,000 litres each with gutters readily connected to harvest rain water.
- iv. The market shed is also connected to piped water.
- v. There was ablution block in the market constructed in the financial year 2019/2020

Specific recommendation

The Committee recommends that the County Ministry of Trade, Industry, MSMEs, Innovations and cooperatives should undertake structural repairs of the market shed and provide an additional water tank of 10,000 litres with a view to mitigating vagaries of climatic conditions of the area.

3.4. Mutha Slaughterhouse.

Mr. Speaker Sir,

The Committee accompanied by the Personal Assistant to area MCA visited the slaughterhouse on 7th August, 2023, who briefed the committee as follows: -that

- i. It is a privately owned slaughterhouse.
- ii. The facility was not connected to water supply, however it uses water from the nearby seasonal river.
- iii. The waste drainage system was not properly covered hence emanating bad smell leading to poor hygienic standards.
- iv. The floor was in a dilapidated condition.

- v. The Committee was informed that the slaughterhouse slaughters at least five goats daily.
- vi. The service charge is collected in cash, with no documentation of the daily transactions.

Specific recommendation

The Committee recommends that the County Ministry of Trade, Industry MSMEs and Cooperatives should: -

- i. Put up, as a matter of urgency, a modern Slaughterhouse in Mutha town to offer better services and boost own source revenue.
- ii. Ensure that privately owned slaughterhouses are in compliance with the minimum standard requirement as provided for in the Meat Control (Local Slaughterhouse) Regulations, 2010.

3.5. Kisasi Stock Sale Yard

Mr. Speaker Sir,

The Committee visited the Kisasi Stock Sales Yard on 8th August, 2023 and noted the following: -

- i. The fence around the stock sales yard has worn out and had developed openings all over.
- ii. The revenue offices had also been neglected and looked dilapidated.
- iii. The cattle dip was in poor state and requires renovation.
- iv. Solar lights had been vandalized and non-operational.
- v. There was an automated system of collecting revenue.
- vi. There is no cattle ramp for loading and offloading livestock.
- vii. Kisasi primary school is at a stone's throw from the Stock Sales yard hence nuisance to the pupils especially during the market day.

Specific recommendations

The Committee recommends that the County Ministry of Trade, Industry, MSMEs Innovation and cooperative should: -

- i. Construct a perimeter wall around the Stock Sales yard with suitable entry and exit points for both livestock and market actors.
- ii. Undertake renovations of revenue offices for conducive working environment.
- iii. The cattle dip should be renovated as to prevent spread livestock diseases.
- iv. In future the ministry should consider relocating Stock Sales yard to other areas outside Kisasi town since where it sits is nuisance to the pupils.

3.6. Kavisuni Stock Sales yard.

Mr. Speaker Sir,

The Committee visited Kavisuni Stock Sales yard on 8thAugust, 2023 and made the following observations: -

- i. The Stock Sales yard fence had worn out thus could cannot control livestock movement.
- ii. The revenue offices had been neglected thus becoming old and abandoned rooms
- iii. Cattle loading and offloading bay required improvement in its structures
- iv. There was only one doors pit latrine which in the opinion of the committee was not sufficient to accommodate large number of traders during the market days.

Specific recommendation

The Committee recommends that the County Ministry of Trade, Industry, MSMEs Innovation and cooperative that: -

- i. Should construct an additional two door pit latrine as a matter of urgency.
- ii. should be construct a perimeter wall around the Stock Sales yard as well as renovate revenue offices.
- iii. infrastructural improvement works should be undertaken on ramp for livestock loading.

3.7. Kavisuni Market Shed.

Mr. Speaker Sir.

On 8th August, 2023 the Committee visited Kavisuni Market Shed, and the findings were as follows:

- i. There was a modern Market Shed which was Constructed in by the County Government in the Financial year 2014/2015.
- ii. There were two water tanks of 5,000 litres, and connected to water gutters which looked loose.
- iii. The chain link fence had worn out leading to many openings into the market.
- iv. The market toilets were dirty with no attendant.
- v. The market Solar lights were not operational thus required Maintenance.
- vi. The market requires skippers and bins for ease garbage collection.

Specific recommendations

The Committee recommends that the County Ministry of Trade should: -

- i. Install and additional water tank of 10,000 litres to harvest rain water.
- ii. Do Maintenance of the market solar lights.
- iii. Place skippers, bins at the designated area for garbage collection.
- iv. Contract at least two market cleaners.

3.8 Kiusyani Market shed.

Mr. Speaker Sir,

The Committee visited Kiusyani Market shed on 8th August, 2023 and the following ware the observations: -That

- i. The market shed was constructed in the financial year 2015/2016.
- ii. There were no sanitary facilities.
- iii. There was a need to consider putting up a modern market with lockable storage as the current one was not sufficient.
- iv. There was a need for two water tanks of 5,000 litres for harvesting rain water from the market shed.

Specific recommendation

The Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives, should construct an ablution block, install two water tanks of 10,000 litres each with a connection of gutters system for harvesting rain water.

3.9 Kwa Vonza Market Shed.

Mr. Speaker Sir

The Committee visited Kwa Vonza Market sheds on Tuesday, 8th August, 2023 and observed the following: -

- i. That the business premise was donor funded project called Symbio City, implemented through the Council of Governors in the financial year 2021/2022.
- ii. That the market shed was constructed on a spacious land with decent market structures.
- iii. Despite County Government putting up such trade structures, the market is not operational since the contractor had not been paid since 2021.
- iv. The Committee observed mobile containers piled up in the market shed and not in use.

Specific Recommendations.

The Committee recommends that: -

- i. The county government of Kitui should verify and clear the pending bills regarding this project with a view of handing over the project to the public.
- ii. The County Ministry of trade should undertake proper public participation and sensitization of the public on the need to move street hawker to the new facility.
- iii. That the containers should be transferred to suitable areas within designated busy areas, so as to create more employment opportunities and boost revenue to the County Government.

3.9.1 Kabati Slaughterhouse

Mr. Speaker Sir, the Committee visited Kabati Slaughterhouse on 9th August, 2023 accompanied by the area MCA and the Public Health Officer. The Committee was briefed on the issues surrounding the old and the new slaughterhouses.

The following were the findings and observations: -that

- i. The facility is in a deplorable state, for instance, the floor has developed holes, there is an open waste drainage system, there is no running water, and pilled up waste.
- ii. There was improper handling equipment in the facility.
- iii. Slaughter structures are so old, posing health hazard to meat handlers.
- iv. The slaughterhouse does not meet the basic amenities requirement i.e. water supply for cleaning of equipment, floors etc.
- v. There is also a stalled County Government modern slaughterhouse in the same area.
- vi. The committee was informed that the project stalled due to a pending bill the County owe to the Contractor which is a matter before the Court.

Specific Recommendations

The Committee recommends that the County Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives should endeavor to resolve the pending court dispute amicably with a view to fast tracking the imminent completion and operationalization of the slaughterhouse cognizant to fact that Kabati is a fast-growing town.

3.9.2 Migwani Market Sheds

Mr. Speaker Sir.

The Committee while in Migwani Market shed visit on 9th August 2023, was accompanied by the Sub- County Administrator, Ward Administrator, the Trade Development Officer and traders.

The following were the committee's findings: -

- i. That, the market had been demolished on one side along the road to pave way for the expansion of Kibwezi-Kitui-Migwani highway.
- ii. The committee found that the ministry was in the process of putting up a fourdoor ablution block which was affected by the ongoing demolitions together with market dumping site.
- iii. The committee noted that the market lacked basic infrastructural utilities i.e. water tanks, gutters system for harvesting rain water, drainage sewerage systems and solar lights.
- iv. traders have moved outside the market shed to give room for renovations thus endangering lives of trader owing to the busy road.

Specific Recommendations.

The County Ministry of Trade, Industry, MSMEs, Innovations should: -

- Move with speed and put up the infrastructural utilities i.e. installation of four
 (4) tanks of water each 10,000 litres, repair of gutters, construction of drainage
 sewerage systems and installing solar lights.
- ii. Placement of mobile waste bins in strategic point in the market for ease garbage collections.
- iii. In future consider constructing storey building to make use of up-ward space to maximize on the limited space.

3.9.3. Nguutani Market Shed.

Mr. Speaker Sir

On 9th August, 2023 Committee visited Nguutani Market shed, the members were received by Ward Administrator together with the Chairman of the Market, who shared with the Committee on the following information: -that

The project was funded by the National Government, until the year 2013, when the County Government of Kitui took over its operations and constructed the public toilets and installed of fence.

Upon its completion, the committee established that, traders used it for some few months and eventually shifted again to open air market citing unfavourable competition from shop-owners.

Members made the following observations that;

- 1. There exists constant conflict between the shop-owners and grocery dealers.
- 2. There is acute water shortage and no power connection making the operations of the market difficult.
- 3. There is a deliberate attempt by some locals to grab the land where the market sits as evidenced by illegal constructions within the market.

Specific Recommendations.

That Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives should: -

- 1. Ensure connection of solar lights and a constant water supply through extension of Masinga- Mwingi water pipeline to the market.
- 2. Ensure immediate renovation of the market by installing metallic doors as well as reinforcing the fence.
- 3. Ensure public participation to educate the traders on the importance of market utilization to the locals, the employment and economic empowerment that comes along with such.

3.9.4. Nguni Market shed.

Mr. Speaker Sir.

The Committee visited Nguni Market Shed on 11th August, 2023, members were received by the Ward Administrator, and the business community.

The following were their submissions: -

- i. The market was faced by acute water shortages occasioned by the breakdown of water pump machine.
- ii. It was constantly said that, the water supplied in the market was too salty which has led to corrosion of the elevated water tank thus causing leakages.

- iii. The business people told the Committee that the water supply served an estimated sixty households in Nguni town.
- iv. The market has persistently faced by water shortages endangering lives of those doing cleaning of the toilets and the traders at large.

Specific recommendations

The Committee recommends that: -

- i. The County Ministry of Trade in collaboration with the Ministry of Water and Irrigation should seek for a lasting solution of the perennial water shortages.
- ii. The Ministry of Trade should liaise with the Ministry of Water and irrigation to ensure that there is constant and adequate supply of clean water.

3.9.5 Kitui Slaughterhouse

Mr. Speaker Sir,

The committee visited the Kitui slaughterhouse on 10th August, 2023 and made the following findings:

That it is main slaughterhouse in Kitui Town and began its operations in the 1980s. It has been faced by numerous challenges including: -

- Understaffing -the manpower to handle the day-to-day operations are few and overwhelmed by workload.
- ii. Power outages -the committee was informed that in occasions of power interruptions there is no power back up.
- iii. Water Shortage -the committee was informed that there is no sufficient and reliable water source to serve the facility.
- iv. Poor Waste management -the committee observed a pool of undissolved animal waste from the slaughter house which posed public health hazard.
- v. The facility uses the traditional/ manual method of slaughtering, making its low compared to work load.

Specific recommendations

- i. The County ministry of TIMIC in partnership with the Kitui Municipality through County Ministry of Lands, Infrastructure and Urban Development should employ an additional workforce and equip them with requisites training skills.
- ii. The County ministry of trade in conjunction with Kitui municipality and the department of water should sink a borehole within the premises of Kitui slaughterhouse with a view of alleviating the perennial water shortage in the latter.
- iii. The County Government should provide central garbage collection centres for materials that can be recycled, establish waste management infrastructure to promote source segregation, collection, reuse, and installation of generator/solar lighting for power back up.
- iv. The ministry of Trade, Industry, MSMEs, Innovations and Cooperatives in collaboration with the Kitui municipality through the relevant department/agencies should ensure proper treatment of the waste emanating from the slaughterhouse.

4.0. GENERAL OBSERVATIONS.

Mr. Speaker Sir,

Having made several sites visits the committee makes the following general observations: -

- i. The Committee observed that most of the market sheds lacked proper infrastructures utilities such as modern toilets, solar lights, fences and water connectivity.
- ii. The Committee observed that most of the stalled market sheds, members of public were not involved in decision making of coming up with such areas of such structures as envisages in Article 174 (c) of the Constitution of Kenya on the public participation.

- iii. The Committee learnt that Most slaughterhouses are privately owned and in a deplorable state with the County Government having limited control over them since they are under private ownership.
- iv. The Committee learnt that water scarcity has been predominantly witnessed in all the area the committee visited including markets shed and slaughterhouses.
- v. The Committee observed that revenue collections was in cash thus likely trigger theft or even endanger officers handling cash.
- vi. The Committee observed that there is largely use of electricity power which was expensive compared to green energy which is sustainable.
- vii. The committee observed that waste management has been a great matter of concern since the main challenge of the slaughterhouse rests with the impacts on the environment.

5.0. COMMITTEE'S RECOMMENDATIONS

Mr. Speaker Sir.

In respect to the above findings and observation the Committee makes the following recommendations that: -

- i. The Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives should renovate and improve the existing markets by constructing modern toilets, installing solar lights and water tanks. This will enhance a conducive environment for business activities well as an enabling infrastructure for trade.
- ii. The County Ministry of trade Industry, MSMEs, Innovations and Cooperatives should ensure that private slaughterhouses in County are in compliance with relevant regulatory framework.
- iii. The County Ministry of TIMIC in liaison with the Ministry of water and Irrigation should develop an all-inclusive County Water Strategy policy on Water Resource Management, maintenance and rehabilitation.
- iv. The County Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives should fully engage the public on development projects and pro-grammes in line with the principles of citizen participation as envisaged in Article 174 (c) of the Constitution of Kenya. This will give members of the public an opportunity to prioritize their needs, hence enhancing sense of ownership.
- v. The County Ministry of Trade, Industry, MSMEs, Innovations and Cooperatives should automate revenue collection to enhance efficiency and effectiveness.
- vi. Since most of the skins and hides are thrown away to waste, the Committee recommends that the County Ministry of trade should:
 - a) Build hides and skin collection Centre at every Sub County;
 - b) Create two central processing unit for the hides and skins one at Nguni in Mwingi Central and other one at Kisasi in Kitui rural;

- c) Market the hides and skin as either raw treated products or process for sale to footwear industry, for production of garments, furniture and travel goods.
- d) Build modern slaughterhouses for the County at every Sub County as well as modernize the Kitui and Mwingi slaughterhouses.
- vii. The committee recommends that the County ministry of TIMIC in conjunction with the Kitui municipality through the relevant county ministry should endeavor to establish waste treatment plants with a view to ensuring clean environment in and outside the slaughterhouse premises.

6.0 CONCLUSION

Mr. Speaker Sir,

The inspection exercise was valuable for it accorded the Committee an opportunity to get the facts as they are on the ground hence coming up with useful recommendations that once implemented, the Kitui Citizenry living standards will be uplifted and their livelihood enhanced.
