COMMUNICATION AS RELATES TO THE RETIREMENT OF THE CLERK OF ASSEMBLY, AND THE APPOINTMENT OF THE ACTING CLERK AND ACTING DEPUTY CLERK OF ASSEMBLY.

I wish to bring to your attention the retirement of Mr. Elijah Mwova Mutambuki, who officially retired as the Clerk of Assembly on 30th June, 2024. Mr. Mutambuki has been an exemplary public servant for over thirty (30) years and has served as the Clerk of the County Assembly of Kitui since the onset of devolution in 2013. In this regard, I wish to inform you that the Kitui County Assembly Service Board (KCASB) appointed Madam Lucy Nduku Waema, the Deputy Clerk of Assembly, as

the Acting Clerk of Assembly with effect from 1st June, 2024 for a period of six

months.
