Deputy Speaker (Hon. Christopher Nzioka): Thank you Hon. Katumbi. The point is well noted. Hon. Ngwele.

Hon. Joseph Ngwele: Mr. Speaker I rise in response to the communication that we cannot proceed on the report for the Committee on Implementation because the Chair is held in another County Assembly business. To the best of my knowledge, that Committee has a vice Chair. Should we defer business of the Assembly simply because of the absence or the commitment of the Chair while has a substantive vice Chair. What has happened to the vice Chair?
