Hon. Godffrey Ndagara: Mr. Speaker thank you for the directive because budgeting is very important and it is good that we get acquainted with it the third since we got elected and has a lot of concern for many of us and therefore in advance, I want to thank the Budget Committee. We were expecting our Chair to tell us that he was seeking for more time but thank God he has adhered to what we told him and we really appreciate. I want to talk about a different issue. You realise the public is quite concerned out of the budget. They are calling us every time and I know many of my colleagues have been called by people that we should not pass the Finance Bill. So the public do not know the difference between the National Assembly and the County Assembly. Therefore, I think it is good you give us the time to tell our MPs the position of the many people who are calling us to tell us to tell them. I know it is not our issue but since the people of Kitui are quite concerned about the Finance Bill, I think you should give us two to three minutes to ventilate on it. This will be of paramount importance.

Temporary Speaker (*Hon. Paul Maluki*): We have heard you Hon. Ndagara but as far as I'm concerned, that is not part of our today's business and even if we were to give our opinions here, they don't really matter. But you can call your people and tell them whether you are opposing or in support. That will make more sense than discussing it here. The County Government of Kitui is going to bring its own Finance Bill through the Ministry of Finance and Economic Planning. That is when now the members of public can raise their concern after going through the Bill. Chair, Budget thank you for tabling the report as we agreed last week. We know it is tedious and very engaging. Once again Members make sure before you leave for home you get a copy of the Budget Committee Report and acquaint yourself with the resolutions before the debate tomorrow.
