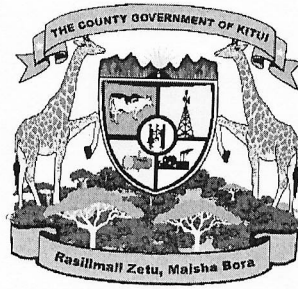

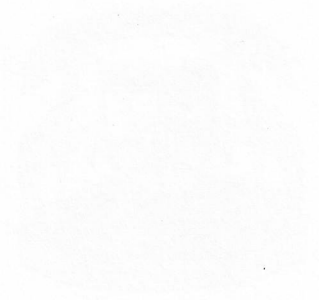

The Board of Directors of the American Association of University and College Teachers is composed of representatives of the various branches of the Association, and is authorized to act on behalf of the Association in all matters relating to its general interests and to the promotion of its objects.

2. The Board of Directors shall have the honor and the confidence of the members of the Association, and shall be held responsible to them for its conduct.

3. The Board of Directors shall have the right to call and convene the Annual Meeting of the Association, and to determine the time, place, and agenda of such meeting.

4. The Board of Directors shall have the right to elect and remove the officers and members of the Executive Committee, and to determine the powers and duties of such committee.

5. The Board of Directors shall have the right to elect and remove the officers and members of the Finance Committee, and to determine the powers and duties of such committee.

6. The Board of Directors shall have the right to elect and remove the officers and members of the Publications Committee, and to determine the powers and duties of such committee.

7. The Board of Directors shall have the right to elect and remove the officers and members of the Honorary Committee, and to determine the powers and duties of such committee.

8. The Board of Directors shall have the right to elect and remove the officers and members of the Nominating Committee, and to determine the powers and duties of such committee.

9. The Board of Directors shall have the right to elect and remove the officers and members of the Resolutions Committee, and to determine the powers and duties of such committee.

10. The Board of Directors shall have the right to elect and remove the officers and members of the Special Committees, and to determine the powers and duties of such committees.

11. The Board of Directors shall have the right to elect and remove the officers and members of the Executive Committee, and to determine the powers and duties of such committee.
